How does a produce prescription work?

Patient is diagnosed with a health condition



Healthcare provider determines that fresh produce is an appropriate treatment



Patient is given a prescription for fresh produce



Patient fills the prescription

Purpose of Produce Rx RFA



The purpose of this RFA:

- Fund high-quality produce prescription programs
- Support culturally appropriate, community-tailored approaches
- Improve the health of Marylanders living in high-poverty areas (ENOUGH-eligible communities)
- Create lasting impact by connecting community members with local food resources, primary care doctors, and other wraparound services

RFA Components

Applicant Mandatory Requirements

- Apply as a **Produce Prescription Coalition**
- Serve **ENOUGH-eligible communities**
 - Census tract with a child poverty rate of 30% or higher, **AND**
 - Public school catchment area with a school poverty rate of 75% or higher
- Lead applicant must be an **eligible entity**:
 - Nonprofit organization
 - State or local government agency
 - Public college or state university
- Be in **good standing** with the Maryland SDAT

Scope of Work

The produce prescription should serve **at least one** of the following clinical populations within an ENOUGH-eligible area.

- Adults with high-risk pregnancies
- Adults with hypertension
- Other nutrition-sensitive conditions (e.g., diabetes, prediabetes, obesity, cardiometabolic diseases)

Applicant's proposed projects should:

- Screen and identify patients meeting clinical and nutritional insecurity criteria.
- Provide culturally relevant produce boxes for 6 months
 - Boxes should prioritize home delivery
 - Preference given for projects that include Maryland agricultural products
- Connect patients to primary care and provide or refer to evidence-based wraparound services (nutrition education, kitchen equipment, peer navigators, benefit referrals, and social connection).
- Participate in the program evaluation

Coalitions

Two or more organizations operating together to implement a produce prescription program. Each Coalition must designate a Lead Applicant.

- **Examples of Potential Coalition Members:** Community-Based Organizations, Local Health Departments, Hospitals, Food Banks and Pantries, Social Service Providers, Health Systems, Federally Qualified Health Centers (FQHCs), Faith-Based Organizations, Farms and Farming Collectives, Healthcare Providers and Provider Groups, Area Agencies on Aging (AAAs), Universities, Community Coalitions and Resident Leadership Groups, Grocery Stores and Farmers Markets, Schools

***This list is not exhaustive.**

Purpose of Coalitions

- **Advances the State's vision** of partnership, community engagement, and addressing service gaps across Maryland
- **Brings organizations together** to align around shared goals
- **Leverages collective strengths and resources** to create scalable solutions that no single organization could achieve alone
- **Builds coordinated, strategic initiatives** with multiple, reinforcing program elements that improve community impact
- **Strengthens the Produce Rx ecosystem** by connecting healthcare, food access, and community partners to improve health outcomes
