ABOUT US

The Health Department of Allegany County, Maryland was established in 1923 and exists by law as a state public agency under the Maryland Department of Health. The organization is under the direction of the County Health Officer who, together with the entire staff of the Health Department, is dedicated to assessing and assuring that the health of community residents is protected and optimized.

The Allegany County Health Department is made up of several major divisions, including Administration; Environmental Health; Behavioral Health (Addictions & Mental Health); the Local Behavioral Health Authority (LBHA); Community Support Services Office (CSSO); Women, Infants and Children (WIC); Dental Health; Physical Health; and Public Health Preparedness. Services are provided through clinics; school and home visitation; evaluations; consultations; counseling; outpatient and inpatient treatment centers; educational presentations and campaigns; health inspections and licensing; and financial certification for specialized services. The Health Department is funded through county, state, and federal revenues and the annual budget requires the approval of both county and state governments.

Fees are charged for most services. Chargeable services are provided based on a sliding fee scale according to income. No one is denied care or treatment because of inability to pay. Health Department services are listed in the telephone directory under Allegany County Government.

VISION: Healthy people, healthy communities.

MISSION: Promote physical, behavioral, and environmental health, and prevent disease and disabilities of people in Allegany County.

VALUES: This mission is a community-wide public health partnership achieved through:

- Building safe and healthful communities for people in Allegany County.

ADMINISTRATION

The Administrative Division contributes to the overall operation and management of the entire Health Department. Led by the Health Officer, Medical Deputy Health Officer, and Administrator, this division is responsible for collecting data and monitoring public health in our communities. This planning function works to improve availability and access to needed services for county residents by partnering with relevant organizations and agencies.

Administrative functions include Human Resources; Purchasing; Accounting and Fiscal Management; Information Technology, Timekeeping and Payroll.

BEHAVIORAL HEALTH SERVICES

Our mission is to provide comprehensive, high-quality mental health, addiction and prevention services to adults, adolescents and children. Services are personalized, accessible, efficient and effective. We work with the community we serve in achieving our mission.

The Addictions Programs provides prevention and treatment services to individuals and families at risk as well as to those experiencing substance use disorders.

Outpatient Addictions services are provided at the Brook Building to individuals and families experiencing substance use disorders.

Allegany House (Halfway House): 301-777-2497

Allegany House is a 14 bed (8 male and 6 female) halfway house for adults recovering from drugs and alcohol who are in need of a structured, supportive living environment that encourages positive growth toward maintaining sobriety and achieving self-sufficiency. Allegany House is staffed 24 hours per day/7 days per week. Services include the following:

- 24-hour supervision and support
- Daily meals provided
- Individual and group counseling
- Relapse prevention
- Life-skills training
- Person-centered treatment planning
- Peer support (group/individual)
- Community referrals
- Vocational assistance

Joseph S. Massie Unit: 301-777-2285

Massie Unit is a 45-bed inpatient treatment facility for adults experiencing the devastating effects of drugs and alcohol. The length of stay is individualized and may vary from three to eight weeks depending on the patient's treatment needs. The unit is located at the Finan Center, Country Club Road, Cumberland, Maryland. Services include the following:

- History and physical within 24 hours of admission
- Psychosocial assessment
- Person-centered treatment planning
- Withdrawal management
- Medications for opiate use disorder
- Individual, group, and family/couples counseling
- Educational presentations and resources
- Relapse prevention
- Psychiatric evaluation
- Gambling assessment/counseling
- Family education
- Self-help groups (Alcoholics Anonymous/Narcotics Anonymous)
- Peer support (group/individual)
- Comprehensive aftercare/transition planning

MENTAL HEALTH SERVICES

Mission and Staff:

The center offers an array of mental health services to meet the individualized needs of patients of all ages, including those patients requiring intensive outpatient care. Our staff assists clients in accessing and coordinating appropriate community resources. Staff includes psychiatrists, nurse practitioners, licensed master's degree counselors, registered nurses, and support staff.

Adult Services:

- Specialty groups such as dual diagnosis, panic-anxiety disorder, impulse control, depression and codependency group
- Individual and family therapy
- Intensive Outpatient Program
- Medication services

Child and Adolescent Services:

- K.I.D.S. Kids Intensive Day Services (Intensive Outpatient Program)
- Individual, Family, and Group Therapy
- School-based services
- Medication services

Hours of Operation:

Monday, 8 a.m. to 5 p.m. Tuesday through Thursday, 8 a.m. to 6:30 p.m. Friday, 8 a.m. to 5 p.m. After-hours and weekend crisis coverage. In-school and home-based services provided.

DENTAL HEALTH PROGRAM

Mission & Staff:

To promote preventive dental programs for residents in Allegany County, to provide quality dental services for residents in Allegany County who have an active MA/MCO card, to provide medically necessary limited urgent dental care to residents lacking access, to deliver dental services in a positive environment with high professional standards, and to offer services with patience, empathy, respect and tolerance to promote a positive dental experience for each patient who visits the clinic.

Staff includes licensed dentists, dental hygienists, and dental assistants. The dental clinic is located in the Brook Building, Entrance Door #4. Dental care is by appointment only.

Services Provided:

- Dental clinical services including cleanings, fluoride treatments, sealants, radiography, space maintainers, restorative care (fillings), sports mouthguards, and extractions.
- School screenings in Head Start programs and Judy Centers in Allegany County.
- Dental health education for the community and educational materials available for community use.
- School-based oral health program for all elementary students enrolled in any ACPS elementary school, providing sealants, fluoride, and dental exams.
- Adult extraction clinic and limited adult urgent care for uninsured clients.

Who Is Eligible:

- Any resident of Allegany County who has a valid Maryland Medical Assistance Maryland Healthy Smiles card.
- Allegany County residents identified as needing urgent or immediate treatment by the school screening process. Siblings of these children are also eligible.
- Dental care is provided for the Mountain Youth Center residents.
- Extractions are offered to low income clients on a sliding fee scale and those who have a Maryland Medical Assistance card.
- Limited urgent care for adults and children without access to a dentist.

ENVIRONMENTAL HEALTH

Mission and Staff:

The Environmental Health program is dedicated to providing a safe and healthful environment for the residents and visitors of Allegany County. The Environmental Health office is located in the Willowbrook Office Complex on the ground floor.

Services Provided:

- Wells: Sampling of newly constructed wells, issuing permits, and construction inspections.
- Non-Community Water Supplies: Regulatory sampling, inspections and evaluations.
- Water Quality: Information and complaint investigation.
- Swimming Pools, Spas, Bathing Beaches: Regulatory inspections and complaint investigations.
- Soil Evaluation and Percolation Tests for new lot construction and subdivisions.
- Individual Sewage Systems: Inspections and evaluations.
- Food Sanitation for Permanent and Temporary Food Service Facilities:
 Licensing, inspections, plan reviews, investigation of food-borne illness and food safety complaints.
- Rabies Control: Case investigation. Rabies vaccination clinics twice per year.
- Psittacosis Control: Issuing permits, inspections and complaint investigations
- Residential and Commercial Burning Permits and Site Inspections.
- Sanitary Surveys and Site Inspections.
- Radon and Indoor Air Quality: Public education.
- Waste Disposal: Inspections and public education on home medical waste disposal and disposal of household hazardous waste.
- Camps and Mobile Home Parks: Issuing permits, regulatory inspections and complaint investigations.
- Day Care, Foster Care and Adoption Homes: Site evaluations.
- Tattoo Establishments: Issuing permits and regulatory inspections.

HEALTH PLANNING

Mission and Staff:

The Health Planning Department uses data and community input to formulate strategies, and develops community partnerships to improve the health and wellbeing of all individuals in the county.

Services Provided:

- Serves as co-chair of the Allegany County Local Health Improvement Coalition (LHIC) which is responsible for conducting community health needs assessments, building partnerships within the community, and developing the County Health Improvement Plan (CHIP). https://alleganyhealthplanningcoalition.com/ or 301-759-5259

LOCAL BEHAVIORAL HEALTH AUTHORITY

Mission and Staff:

The Local Behavioral Health Authority (LBHA) is the designated county authority responsible for planning, managing and monitoring the county's publicly funded mental health and substance use disorder services for individuals in Maryland's Public Behavioral Health System (PBHS). The PBHS provides behavioral health services to individuals with Medical Assistance and to individuals who are uninsured and meet established criteria. Additionally, the LBHA provides a number of behavioral health support services described below. The LBHA is located on the first floor of the Willowbrook Office Complex.

LBHA Core Functions: *301-759-5070*

- Planning, managing and monitoring the development and delivery of services provided through both Maryland's fee-for-service system and through purchase of service contracts with local providers.
- Supporting and promoting behavioral health wellness, recovery and resilience and providing public education and stigma reducing activities.
- Providing advocacy services for individuals within the public behavioral health system to assist them with accessing needed services.

Who Is Eligible:

Education and referral services are available to anyone involved with or interested in knowing about Maryland's Public Behavioral Health System.

Community Criminal Justice New Horizons Re-Entry Program: *301-759-5096*

Assessment, release planning and aftercare services for inmates with a mental illness who are being released from any jail or prison and returning to Allegany County.

Projects for Assistance in Transition from Homelessness (PATH):

301-759-5111

Provides assistance in locating housing resources to individuals with mental illness who are eligible for Maryland's Public Behavioral Health System and who are homeless and/ or being released from incarceration.

Who Is Eligible:

Services are available to individuals with Medical Assistance or are uninsured, are currently or at imminent risk of being homeless, and have a serious mental illness diagnosis.

State Care Coordination: *301-759-5110*

Maryland State Care Coordination services are available to adults who are being discharged from residential substance use treatment (Levels 3.7, 3.5, 3.3 or 3.1) and who reside in Allegany County. State Care Coordination is designed to expand access to a comprehensive array of community-based recovery support services for individuals in varying stages of recovery. All services are designed to assist recipients in remaining engaged in their recovery while promoting independence, self-sufficiency, and stability as they transition back into their communities. In order to be enrolled in the program, a consumer must meet eligibility requirements, must have independently chosen to enroll and participate in the program, and must be referred through a designated portal/access point.

NUTRTITION SERVICES

Mission and Staff:

The ACHD Nutrition Program is dedicated to promoting health and well-being in Allegany County. Our initiatives are designed to improve health outcomes, ensure access to healthy foods, and strengthen our local food system. Our staff includes one registered dietitian nutritionist and one office clerk.

Services Provided:

- Group nutrition education classes held at ACHD and throughout the county
- Nutrition counseling for ACHD program participants

 Collaboration with community programs to improve the food system and overall health, including the Western Maryland Food Council (WMFC), Maryland Food System Resiliency Council (FSRC), University of Maryland Extension (UME) Advisory Committee, and Allegany College of Maryland's Community Resilience Network (CRN)

Hours of Operation:

Monday through Friday, 8 a.m. – 4:30 p.m. Some classes held from 4:30-5:30 p.m. Other times available by appointment only.

PHYSICAL HEALTH SERVICES

Mission and Staff:

Physical Health Services are designed to promote healthy people in healthy communities through a variety of programs designed to serve all ages: children, adolescents, adults, and the elderly. Offices are located on the first floor of the Willowbrook Office Complex (WOC) building. Depending on the program, services are provided in clinics at the WOC location, in client homes, and in public schools.

ADULT SERVICES

Assessment Evaluation and Review Services (AERS): *301-759-5210*

Provides assistance to aged and functionally disabled individuals who are at risk of institutionalization. AERS staff conducts a comprehensive evaluation to identify services available to help the individual to remain in the community, or in the least restrictive environment, while functioning at the highest possible level of independence and personal well-being. AERS also administers the Nurse Monitoring Program for Community Personal Assistance Services (CPAS), Community First Choice (CFC), and Community Options Waiver (COW) participants.

Breast and Cervical Cancer Services: *301-759-5083*

Provides breast cancer screening services to low income, uninsured women aged 40 and older and cervical cancer screening to women aged 21 and older. Must reside in Maryland and meet income requirements. Provides payment for screenings (breast exam, mammogram, Pap test), and diagnostic testing if needed. Will also provide treatment services for breast or cervical cancer. Also provides the same services to persons with health insurance in order to assist clients with completion of screenings and can provide transportation to and from appointments if necessary.

Colorectal Cancer Screening Program: *301-759-5083*

Provides colorectal cancer education, screening, diagnostic, and treatment services to low income persons aged 50 and older. Will provide services to persons younger than 50-must have a referral from a healthcare provider. Must reside in Maryland and meet income requirements. Program also provides the same services to

persons with health insurance in order to assist client with completion of screenings and can provide transportation to and from appointments if necessary.

HIV Testing Services: 301-759-5138

Provides free confidential HIV counseling and testing Monday through Friday from 8 a.m. to 12 p.m. and 1 p.m. to 3:30 p.m. Quick testing with results determined in 1 minute.

HIV Clinic and Case Management: *301-759-5085*

Provides medical case management services to Maryland residents who test positive for HIV. Johns Hopkins University provides clinical HIV specialty care to enrolled clients two days per month.

Immunization Clinics: *301-759-5138*

The ACHD provides a variety of childhood, adolescent, and adult immunizations. Clinics are held Wednesdays from 1 to 4 p.m. No appointment needed. Bring insurance information and any immunization records, if available.

Lung Cancer Screening Program: *301-759-5083*

Provides lung cancer education, screening, diagnostic and treatment services to low income persons aged 50-80 who presently smoke or recently quit smoking. Must have a long history of smoking. Must reside in Maryland. Program will provide payment to see a healthcare provider to discuss lung cancer screening and a low dose CT scan. Must be uninsured, or have health insurance that does not cover lung cancer screening.

Persons with lung disease, environmental exposure to radon or other chemicals or a family history of lung cancer may also qualify for a no cost lung cancer screening.

Maryland Cancer Fund: 301-759-5083

Provides grants to assist Maryland Residents with payment for cancer treatment or for diagnostic testing to rule out cancer. Cancer must have been diagnosed in the last 6 months. Must meet income requirements. This fund is made possible through Maryland taxpayer donations.

Overseas Immunization Clinic: 301-759-5138

By appointment. Review and provision of immunizations for overseas travel. If possible, call at least one month prior to travel to schedule an appointment.

Skin Cancer Screening Program: *301-759-5083*

Provides skin cancer education, screening, diagnostic and treatment services to low income persons aged 19 and older who have a personal history or family history of skin cancer, or who have skin changes such as mole that has grown in size, changed in color, or has jagged edges/is irregular in shape. Must reside in Maryland. Must be uninsured, or have insurance that does not cover skin cancer screening. Program will pay for a visit with a dermatologist for a skin cancer exam.

STI (Sexually Transmitted Infections) Clinic: *301-759-5245*

Confidential STI/HIV testing and treatment. Clinic every Tuesday from 8

a.m. to 10:45 a.m. and 12 noon to 3:00 p.m. No appointment needed.

CHILD AND ADOLESCENT SERVICES

Administrative Care Coordination Unit (ACCU) Ombudsman: *301-759-5094*

Provides help to Medical Assistance clients with understanding and access to the managed care system; follow-up of non-compliant clients. Provide education to Maryland Medical Assistance patients including enrollment into Healthchoice MCOs, coverage, and benefits. Ombudsman handles more complex issues, hard-to-reach clients, and non-compliance issues.

Children and People with Special Health Care Needs (CPSHCN): 301-759 - 5079

Telephonic care coordination services for special needs children and youth who have or are at increased risk for any chronic physical, developmental, or emotional condition.

Genetics: 301-759-5079

Provides genetic consultation, diagnosis and monitoring for special needs children and youth. Clinical services are provided by the University of Maryland Hospital Center and ACHD staff.

Healthy Families Allegany County: *301-759-5079*

Home visiting program designed to support expectant mothers and new families. Our staff consists of experienced Maternal-Child Health Nurses and Preschool Early Educators to help you where it matters most. We will support you in the topic of your choice at each visit. Whether it be the next milestone, a behavior concern, a health question, or a crisis situation, we will be there to support you by providing answers, suggestions, or just a listening ear from a trusted adult you can count on. HFA staff are relationship builders, helping parents develop strong connections with their children and community while improving the parent-child bond. We can help you focus on your goals, meet your needs, and set your child up for long-term life success. During your enrollment in the program (pregnancy through age 3) we will offer activities, milestone-appropriate toys and items, fun family events, referrals as needed, and get your child set up for transition into preschool if desired.

Infants and Toddlers: *301-759-5081*

Collaborative effort with the Allegany County Board of Education and the Allegany County Department of Social Services. The program provides home visits for OT, PT, speech, special instruction, and service coordination to developmentally delayed children birth to 4 years of age.

Maryland Medical Assistance Eligibility Unit: *301-759-5076*

Assists clients with the online application process in the Maryland Health connection. Assists with resolving eligibility and certification problems for MCHP, Medicaid, and Qualified Health Plans. Health care coverage plans are available for income-

qualifying children, pregnant women, and adults under age 65.

School Health: *301-759-5088*

The School Nurse Program provides students and faculties in 22 schools with a multitude of health and medical services, including: caring for the sick and injured, administering and monitoring medications, health counseling, education and screening.

Surveillance and Maternal Child Health Initiatives: 301-759-5079

Facilitates the local Fetal/Infant Mortality Review Board with evaluation of all fetal and infant demises. Facilitates the local Child Fetal Review Board with the evaluation of child deaths referred by the state medical examiner. Provides community education regarding the promotion of healthy pregnancy and infant care.

ELDERLY SERVICES

Senior Care Program: 301-759-5210

A program designed to help people 65 or older, who are at risk of entering a nursing home, to remain safely in the community in their own homes for as long as possible. Senior Care provides case management and 'gap filling funds' to purchase services for individuals who meet program eligibility requirements.

National Family Caregiver Support Program (NFCSP): 301-759-5210

As support to caregivers, the NFCSP provides short term services to eligible individuals aged 60 and older.

OTHER PHYSICAL HEALTH PROGRAMS

CHW Improving Health and Resilience Project: 301-759-5098

Community Health Workers provide chronic disease prevention resources and assistance to county residents who may be at higher risk for poor health outcomes, including those resulting from COVID-19. Provides COVID-19 supplies such as masks and testing kits, educational materials related to a variety of chronic diseases and assists clients in need of various community resources.

Infectious Disease/Outbreaks: *301-759-5125*

Investigation, consultation, and disaster response. Services available 24 hours/day, 7 days/week.

Prevention Services:

Prevention Services is an 'umbrella' of programs with the goal of reducing injury and disease through public education and awareness. The staff includes one registered nurse and an outreach worker.

Tobacco Cessation: *301-759-5093*

Focuses on tobacco and nicotine cessation. One-on-one counseling available with a tobacco treatment specialist. No-cost nicotine replacement therapy is offered as part of the counseling services. The goal is to help clients become tobacco/nicotine free. The program also focuses on youth prevention and education, as well as education to pregnant women and women of childbearing age on the importanc eof being tobacco/nicotine free during and after pregnancy.

Tobacco/Chronic Disease Services: *301-759-5262*

These services focus on adult and youth tobacco and nicotine cessation, youth engagement, and education on prevention of diabetes and other chronic diseases. Among the programs offered is TOPS (Taking Pounds Off Sensibly), an overall wellness, weight loss, healthy lifestyle program. Referrals can be made by local healthcare providers, or by clients themselves. The purpose of this program is to work with persons with chronic disease, with a focus on pre-diabetics, diabetics, and anyone with risk factors for diabetes. Call for more information.

Hours of Operation:

Physical Health staff is available during regular business hours, Monday through Friday from 8 a.m. to 4:30 p.m. However, hours and days for specific services may vary. Please call (301) 759-5000 for information on specific programs and services.

PUBLIC HEALTH EMERGENCY PREPAREDNESS

Mission and Staff:

The Public Health Preparedness Office serves the community by providing timely information, preventive measures, and preparedness planning for a wide variety of natural and man-made public health emergencies. This office coordinates with local emergency responders to protect the community from contagious diseases or other health threats. It is also a community resource for education, training, and information on preparedness for emergencies.

Staff includes the Director of Public Health Emergency Preparedness, the Health Department's Public Information Coordinator, and support staff. Offices are located in the Willowbrook Office Complex (WOC) building, first floor.

Information Hotline:

In a public health emergency, our information hotline may be activated. The hotline (301-759-5055) will only be activated as needed and is not normally staffed or checked for messages. In a public health emergency, check the ACHD web site (https://www.myalleganyhealth.org), follow our social media (facebook.com/AlleganyHlthMD) and on Twitter @AlleganyHlthMD), and watch local media for emergency information and announcements about hotline activation.

REPRODUCTIVE HEALTH SERVICES

Mission and Staff:

The Reproductive Health Services program is dedicated to providing comprehensive reproductive healthcare throughout an individual's lifespan, ensuring equitable access to client-centered family planning, reproductive health information, education, and examinations for both men and women, and offering low-cost to no-cost contraception.

Programs and Services:

- Annual well woman exams
- Contraceptive services
- Infertility evaluation
- Pregnancy testing/counseling
- Peri- and post-menopause care
- Breast/cervical cancer screening
- Preconception counseling
- Health promotion/education
- Emergency contraception
- STI testing/treatment
- Chronic condition screening (hypertension, obesity, diabetes, anemia, etc.)

Services are confidential, voluntary, and non-discriminatory based on religion, age, race, color, national origin, gender identification, or sexual orientation. Fees are on an incomebased sliding scale. Most insurances accepted. Appointments are preferred, but walk-ins are accepted.

Hours of Operation:

Monday, Thursday, and Friday, 7 a.m. to 5:30 p.m. Tuesday, and Wednesday, 8 a.m. to 6:30 p.m.

VITAL RECORDS (BIRTH & DEATH CERTIFICATES)

Vital records requests are handled by staff at the front desk of the Physical Health division of the health department.

Birth Certificates: *301-759-5119*

Birth certificates are available at the Allegany County Health Department for a \$20.00 fee. An acceptable government issued (driver's license or MVA issued) photo I.D. or U.S. Passport is required. All identification must have an issue and expiration date; no expired I.D. will be accepted. Birth certificates are provided to the person whose birth record is requested or the person's parents. Birth certificates before 1940 must be obtained from

the Division of Vital Records in Baltimore, Maryland. All legal documents (i.e. court orders, power of attorney, or notarized letter) must be sent to Baltimore with an application to obtain a birth certificate.

Death Certificates: 301-759-5017

Death certificates are issued to funeral directors for deaths that occurred after January 1, 2015. Deaths that occurred prior to January 1, 2015 can only be obtained through the Baltimore office of vital records.

Certified death certificates can be issued to immediate family members for 30 days from the date of death if they are listed as the informant on the certificate. They must present a valid driver's license, MVA-issued photo ID card, or United States Passport. All identification must have an issue and expiration date. The cost of a death certificate is \$18.00 for the first copy and \$20.00 for each additional copy.

After 30 days, a death certificate requested by a family member must be requested from the Division of Vital Records, 6764 B Reisterstown Road, Baltimore, MD 21215. The fee is \$10.00 for the first copy and \$12.00 for each additional copy in the same transaction when applying to the Baltimore office.

Assistance will be offered for other individuals seeking a copy of a death certificate.

WOMEN, INFANTS, AND CHILDREN (WIC)

Mission and Staff:

The WIC program promotes wellness and provides nutrition education programs for Allegany County residents. Offices are located on the first floor of the Willowbrook Office Complex.

Staff can address any questions you may have about breastfeeding your baby. Services available to Allegany County residents and moms who deliver in Allegany County.
