# • Introduction of Chair/Co-Chair – Jordan Lewis and Kathy Whitacre

# • Drug and Alcohol Council (DAAC)

 Jordan Lewis explained that DAAC would now be combined with the Mental Health Advisory Committee (MHAC). Becki Clark, chair of MHAC then explained what this will look like moving forward.

# • Funding for FY 25 strategic priorities and opening of the floor to OPT members to solicit feedback on projects for Allegany County

It was noted by chair Jordan Lewis that there was approximately \$70,000 for projects within this grant. The following ideas were generated and discussed:

- Kathy Whitacre noted how the social determinants of health are always something to focus on improving within the county.
- Becki Clark suggested that there could possibly be an extension of peer work within the county. She suggested possibly Drug Court. James Elliott for the State's Attorney's office then said he felt that peer work would be a good source of funding. Currently Drug Court has about 40 participants and is looking to gain up to 50.
- Kristi Plummer suggested that peer services could tie into the Mental Health Court that is starting in Allegany County.
- It was noted to also check on costs of urinalysis funding and see if this would meet the conditions for funding.
- o Brent Dressman spoke for DSS and stated they would like to continue to work with the ACHD to fund peers at DSS to work within the child welfare unit.
- O Discussion was held about Drug Court looking for funding to complete UA's on evenings and weekends. James Elliott stated he believes they have located funding for this to happen, but he will check. If not, he will reach back out to Jordan.
- Jordan Lewis then opened the floor for the team to continue to suggest options. After no other submissions were made, the meeting progressed to the next order of business.
