# **MARYLAND ACUPUNCTURE BOARD**

### New Changes to Acupuncture Practice Act

Senate Bill 379 – State Acupuncture Board and State Board of Dietetic Practice – Action and Penalties for Violations of Practice Acts and Supervisory Authority of Acupuncturists, Chapter 160 (2014) was signed by Governor Martin O'Malley on April 14, 2014. The new law will give the Board the authority to seek injunctive relief or issue cease and desist orders to individuals practicing acupuncture without a license and subject them to a fine of up to \$50,000. Any funds collected will accrue to the General State Fund. The Boards of Physical Therapy, Pharmacy and Psychology, Physicians and Podiatry already have this authority

The Bill would also give the Board the ability to impose a civil fine on licensees found guilty after a hearing. The fine can be used instead of or in addition to other disciplinary actions. All other health boards have this provision in their law and the Board's Counsel recommended that we attain the same authority. These fines, not to exceed \$5,000, will accrue to the General Fund and will be defined in regulation. The law will take effect on October 1, 2014.

### **BOARD MEMBER VACANCIES**

The appointment terms of **Grant Zhang, Corinne Axelrod and Deneb Falabella** on the Board of Acupuncture are expiring. Ms. Falabella has completed one term and is eligible for reappointment. Mr. Zhang has completed both terms and will not be eligible for reappointment. Ms. Axelrod completed her term and resigned on June 16, 2014. All 3 openings are professional member positions.

Because of the election of a new Governor this year, Board member applications are being put on a <u>temporary hold</u> due to MD Constitutional Provision (Article II §10A). This Provision prohibits Governor Martin O'Malley from making new Executive Appointments between the primary election, June 24, 2014, and the inauguration of the new Governor on January 21, 2015.

After the inauguration, all new applicants will be considered. **The Appointments Office is asking that potential applicants submit an application to fill Ms. Axelrod's position in November and Mr. Zhang and Ms. Falabella's position after January 21, 2015.** Please contact the Board's office to request an application or receive more information.

The Board would like to thank both Ms. Axelrod and Mr. Zhang for their hard work, dedication and expertise while serving on the Board.

### **Tax Clearances for Renewal of License**

The Board has encountered several practitioners who have experienced problems renewing their licenses due to unpaid taxes. The Budget Reconciliation and Financing Act of 2003 requires that the Board must first verify that all renewing licensees have paid all undisputed taxes and unemployment insurance contributions before renewing their license. Therefore, the Board of Acupuncture checks with the State Comptroller's Office to verify that a licensee applying for renewal has paid or satisfactorily arranged to pay state taxes before the Board can issue a license.

If your tax payments are not current, the Board cannot issue a license to you until your taxes are paid or are accounted for payment. Any renewal applicant who may owe outstanding taxes or unemployment insurance contributions should satisfy these debts before attempting to renew his or her license. If the debt cannot be satisfied, the applicant should contact the appropriate party (at the Comptroller's Office or at Labor, Licensing and Regulation) to work out a satisfactory payment plan.

### PRIORITY LICENSING FOR ACTIVE DUTY MILITARY AND RECENTLY DISCHARGED MILITARY VETERANS & SPOUSES

Pursuant to the Veterans Full Employment Act of 2013, military veterans discharged within one (1) year of application for licensing or registration qualify for expedited processing of applications and review of equivalency requests for military training. The Board will expedite review and processing of applications of any military schools or courses submitted as qualifying equivalents for required educational licensing/registration educational standards. The Board extends these privileges to active duty military, including reservists called to active duty for training or deployment. These provisions also fully apply to spouses of active duty and qualifying veterans.

Penny Heisler, the Board's Executive Director, serves as the Board liaison to any qualifying veteran, active duty service member, or dependent spouse who requires information, guidance or assistance on issues relating to licensing and registration

### HAVE YOU MOVED?? FAILURE TO NOTIFY BOARD ON ADDRESS CHANGE \$50.00 FINE

Failure to notify the Board of a change in address will result in a \$50.00 fine. A change in your address can be submitted by mail or email. Whenever the Board receives returned mail from the United States Postal Service, you will automatically receive a fine notice from the Board. Failure to pay the fine may result in disciplinary action against your license.

### NAME CHANGE REQUESTS

The Board will change a licensee's name only when a request is received in writing and proper legal documentation is attached (example: marriage/divorce certificate). Without this documentation, the Board will not reflect the change. Email requests for name changes will not be accepted.

### **VERIFICATION OF LICENSE TO ANOTHER STATE**

To provide verification of your acupuncture license to another state, please send your verification request or form (available on website) directly to the Board with a \$50 check made payable to the Maryland Acupuncture Board. You must provide your name, license number and the state to which you would like the verification mailed. Please ensure that you provide the State's address and phone number.

### IMPORTANT DUPLICATE LICENSES

The Board would like to remind licensees that you are **required to post an** official license in every office, clinic, or practice setting in which you are working. It is no longer permissible to post Xerox or scanned copies of your license in your office. The Board will furnish an official duplicate of your license to any licensed acupuncturist who currently resides in Maryland, free of cost.

## The duplicate license request must be made in writing and an address must be given for each duplicate license requested.

Only one duplicate will be granted for each office. If at any time a license is lost or destroyed, you may request a duplicate, in writing, stating the circumstance under which the license was lost or destroyed.
