WELCOME to the Fall 2023 Renewal Season

The Fall 2023 Renewal Season begins today! Practitioners with November 30, 2023 expiration dates have until Sunday, December 31, 2023 to renew their license. The Fall season is marked by multiple opportunities to celebrate with family and friends. In all the merrymaking, the holidays easily become distractions and for good reason. Consider beating the holiday rush and renewing your license by October 31st. License renewal is an online process that can be completed at your convenience. <u>P-L-E-A-S-E note that no paper applications, checks or money orders are being accepted</u> The renewal fee structure and the corresponding deadlines are as follows:

- \$551 for the standard renewal period October 1 November 30, 2023.
- \$651 for the late renewal, grace period December 1 30, 2023

*REMEMBER - At present the Board is not issuing renewal licenses. To obtain proof of renewal visit the Board's website and click on the <u>Verify A License</u> option in the vertical menu on the left. The search can be completed by license number or last name. This page can be printed by right clicking on your mouse and selecting the print menu option or clicking on the three dots in the upper right corner and selecting the print option.

Continuing Education Unit Requirements Renewal

Proof of CEU completion is a requirement of licensing. A total of 30 is required every two (2) years, with 20 being focused on acupuncture and East Asian medicine. The completion time frame for the Fall renewal period is October 1, 2021 - September 30, 2023. It is sufficient for CEU information to be listed on the renewal application if the practitioner renews on time. If the practitioner renews during the grace period the CEUs must be submitted to the Board via email or mail for the renewal application to be considered complete.



Audit

The Board conducts licensing audits during each renewal season. Practitioners that are randomly selected to participate in the audit MUST also submit the actual CEU certificates to the Board with their renewal application, no matter the submission date. Practitioners chosen to participate in the license renewal audit are notified of their selection by email and mail.

Implicit Bias

As of May 30, 2021 the law requires all health care practitioners in Maryland to attest that they have completed an implicit bias training program on their license renewal application. Contact Information

Did you know that Practitioners are required to ensure that the Board has their most up-to-date information? Did you know that not complying with this requirement will incur a fine? License renewal season is an opportunity to ensure that you are in compliance. When you renew, be sure to share your updated personal and professional information with the Board. The distinction between personal and professional is important because the Board responds to inquiries with professional information.

Mental Health Resource

The Maryland Department of Health (MDH) Behavioral Health Administration (BHA) and MedChi jointly sponsor a webinar series, the BHA/MedChi Behavioral Health Webinar Series: Helping the Helpers and Those They Serve. These webinars are for Maryland's behavioral health and medical health care workers of all disciplines, whether working in community or hospital settings. The webinars are designed to enhance both healthcare worker self-care and the resulting care they provide. It is understood that healthcare workers too face numerous stressors such as the COVID-19 pandemic and issues of socioeconomic justice that can potentially impact care delivery. In some cases, CMEs and participant certificates will be available at no cost, which also may qualify as CEUs for some disciplines. Webinars are on the second Thursday of the month from 5-6pm. National Auricular Detoxification Association

The Annual NADA conference convened on June 22 -23, 2023 at Bowie State University. The Board staff had the opportunity to attend to learn more about the NADA activities and history. One of the many presentations was made by the National Acupuncture Lead for the Veterans Health Administration. Dr. Julie Olson shared about the VHA's intention to expand the role of non-western medicine in the care of veterans. There was an additional exciting announcement about a new textbook that is the result of years of research about positive outcomes achieved through auricular detoxification. Community Impact

September 28, 2023 marks the inaugural anniversary of President Biden's White House Conference on Hunger, Nutrition, and Health (CHNH). Since 2022 the conference has released a <u>National Strategy</u>, and announced over <u>\$8 billion of external commitments</u> to achieve the overarching goal of ending hunger and reducing diet-related disease by 2030.
