2015 Legislation Session

House Bill 979 and Senate Bill 580
State Board of Chiropractic and Massage Therapy Examiners and
State Board of Physical Therapy Examiners
Dry Needling - Registration Requirements

House Bill 979 and Senate Bill 580 were introduced this legislative session to prohibit physical therapists and chiropractors from performing dry needling without registering first with their respective boards and completing training that was at least as stringent as those imposed on physicians who practice acupuncture. Both Bills received an unfavorable report and were withdrawn.

House Bill 232 and Senate Bill 50 State Acupuncture Board-Disciplinary Procedures-Judicial Appeals and Prohibition on Stays

HB 232 and SB 50 would have prohibited an acupuncture licensee from staying a Final Order pending judicial review and prohibit a hearing of charges filed by the Board from being stayed or challenged by procedural defects alleged to have occurred before the filing of charges.

The Board supported these bills as it would have prohibited an acupuncture licensee from staying a Board's Final Order that would revoke or suspend his/her license for committing a serious offense while their case is pending judicial review. The Board only suspends or revokes a practitioner's license for the most egregious cases. The Board was concerned that, without this authority, a dangerous practitioner can stall the order and continue practicing while prolonging an appeal. The Board also supported the prohibition of challenging or staying a hearing of charges because of procedural errors that may have occurred before the filing of charges. The Board believes that technicalities do not change or affect the outcome of a hearing, so a hearing should not be postponed for procedural errors.

Both Bills received an unfavorable report and were withdrawn.

FREQUENT QUESTIONS REGARDING RENEWALS

- If you are audited for CEU's, you can still renew on-line. Simply complete the on-line renewal form in
 its entirety, and send in copies of CEU certificates, the same that you have listed on the on-line form.
 The CEU's listed on-line and the copies of certificates must match or the certificate(s) will not be
 accepted.
- The office cannot accept a licensee's credit card by phone or written on an application. The only
 acceptable method to charge is online renewal.
- If your tax payments are not current, the Board cannot issue a license to you until your taxes are paid or accounted for payment. Any renewal applicant who may owe outstanding taxes or unemployment insurance contributions should satisfy these debts before attempting to renew his or her license. If the debt cannot be satisfied, the applicant should contact the appropriate party (at the Comptroller's Office or at Labor, Licensing and Regulation) to work out a satisfactory payment plan. For questions or concerns regarding this matter, please feel free to call the Comptroller's Compliance Division at 410 974-2432 or toll-free at 1-888-674-0016, for further information.
- Under Family Law Article 10-119.3, the Child Support Enforcement Administration (CSEA) under the
 Department of Human Resources, is authorized to refer the names of delinquent payees to health
 professional licensing boards to request the suspension of their professional license. The CSEA will
 send notification to licensing boards when a practitioner is in arrears more than 120 days under the
 most recent court order. If payments are not made, practitioners could face suspension of their
 professional license or the denial of an initial application. Practitioners will have 15 days of the date of
 receiving the notice of referral to a licensing board to pay the arrears in full or request an investigation
 of the accuracy of the information contained in the notice.

Dry Needling By Physical Therapists The Board of Acupuncture's Role

As appointed officials, the Board of Acupuncture (the Board) is bound to serve as a regulatory unit under the Department of Health and Mental Hygiene, with limited power to influence other health disciplines. The Maryland Acupuncture Practice Act has specific mandates that only allow the Board to set standards to protect the public by:

- 1. Ensuring that acupuncturists are appropriately credentialed and licensed to provide safe acupuncture treatment to Maryland patients;
- 2. Ensuring that acupuncturists maintain a high level of education though renewal of licenses:
- 3. Setting a scope of practice that reflects new and emergent developments through regulations and legislation; and
- 4. Receiving and resolving complaints in an effective and timely manner.

To accomplish these mandates, the Board must work within the confines that have been set by DHMH and the Legislature. As part of DHMH, the Secretary must sign off on all legislative proposals coming from the Health Occupations Boards. The Board recently conferred with Secretary Van Mitchell's staff regarding the possibility of introducing a prohibitive bill to stop dry needling and was told that Secretary would be unlikely to approve such a bill because 1) the main concerns are about scope of practice rather than public health/safety, and 2) the proposal would place restrictions on Maryland businesses without a compelling health or safety rationale. Governor Hogan has set a priority on improving the business climate and he must also approve all Board proposals.

In addition, the Secretary must sign off on all proposed regulations. After 4 years of working on dry needling regulations and entertaining public comment, ,Joshua M. Sharfstein, M.D., the last Secretary of DHMH, signed off on the Physical Therapy (PT) Board's final draft which contained an 80 hour training requirement. Dr. Sharfstein signed the regulation, even though the Board wrote in concerns during the public comment period. This is the extent of the Board's power.

The Acupuncture and Physical Therapy Boards are responsible to formulate a regulation that focuses on protection of the public, not the interests of the two professions. Protecting the interests of the professions is role of the Professional Associations. Also, the Board can not dictate scope of practice to another board. Individual boards have the right to set their own scope of practice. The Legislature is the only authority that can approve changes in practice acts that modify the scope of practice of any healthcare profession.

The Board continues to work the Board of Physical Therapy to negotiate further on the regulations as the Board continues to have concerns with their current proposal. The PT Board has stated that they are open to the Board's input.
