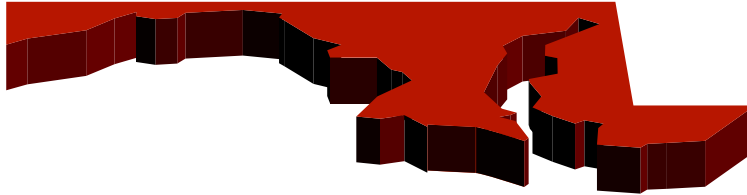

HB628/SB517 Secretaries of Principal Departments – Supervision and Review of Decisions and Actions by Units within the Departments. This legislation provides that the Office of Administrative Hearings will review certain decisions of the Health Occupation Boards regarding restraint of trade consequences.

HB880/SB 450 Opening Meetings Act – Annual Reporting Requirement, Web Site Posting, and Training. The legislation requires that a public body designate a member to take a training course on the Open Meetings Act.

SB/503 Health Occupations Boards – Racial and Ethnic Disparities. Requires the Health Occupations Boards to make certain efforts to educate their licensees regarding racial and ethical disparities.
