CALL TO ORDER

The meeting was called to order at 10:00 A.M. by Bert Nixon, Board Chair.

Pursuant to State Government article 10-508 (12) of the Annotated Code at 11:14 A.M. the members present voted to meet in Administrative Session to discuss confidential disciplinary matters. The Administrative Session ended at 11:25 A.M. and the Open Session Resumed.

ITEM 1 Approval of Minutes

The minutes for the August 2, 2017 Open Session meeting were accepted as amended. Motion was made to accept the minutes as amended. Motion passed. Vote - 8.

ITEM 2 Approval of Agenda

The Agenda was approved and adopted with one adjustment. The Board moved to begin with Item 4 Credentialing on the Agenda, 4(b) Application Process. Motion was made to Accept. Motion passed. Vote -8.

ITEM 3 Board Chair Report: Bert Nixon

3a). The Board Chair welcomed and introduced the new At Large Board Member, Ann Rose. Introductions took place then Ms. Rose gave her

background and experience with the Board and expressed her pleasure with the direction the Board has taken with the license renewal process and continuing education process.

3b). Included in the Annual Report were the following House Bills:

HB628/SB571 Secretaries of Principal Departments – Supervision and Review Decisions and Actions by Units within the Departments. This legislation provides that the Office of Administrative Hearings will review certain decisions of the Health Occupation Boards regarding restraint of trade Consequences. – This Bill will have a low impact on the Board.

HB880/SB450 Open Meeting Act – Annual Reporting Requirement, Web Site Posting, and Training. The legislation requires that a public body designate a member to take the training course on the Open Meetings Act. – The training is an online training. Board Counsel advised that at least one person should be designated however as many as possible should attend. Karen Brandt, Linda Rudie and Yvonne DeLoatch had attended in the past. Jim Merrow asked that an e-mail be sent to him for the members who will attend.

SB503 Health Occupations Boards – Racial and Ethnic Disparities. Requires the Health Occupations Boards to make certain efforts to educate their licensees regarding racial and ethical disparities. – This bill has low impact on the Board.

- **3c).** Meeting with Secretary Schrader Linda Rudie attended and reported back. The meeting was with various Boards, the Secretary has support for the Boards and wants to schedule future meetings. There is possible legislation to move the Board into General Funds.
- **3d.**) Board Chair announced regrettably that James Clise longtime licensee in the profession had passed away at the age of 85.

ITEM 4 Executive Director Report: James Merrow

- **4a).** To date 5 licensees have met their required continuing education credits for license renewal.
- **4b).** The Private Sector member had been posted on the Board's webpage and sent out to licensees in an e-mail. Amy Parrish, currently the Private Sector member, had re-applied.
- **4c).** The new board member orientation is scheduled for Monday, December 4, 2017. It is recommended that new Board Members attend. Invitation letters will be mailed out from the Secretary's office.
- **4d).** The webpage update is a work in progress the Board staff is working with the Database Administrator to put the updates in place.

Kristen Neville relayed to the Board that the Regulations were currently in a holding pattern. The regulations were sent downtown to be reviewed then to the Governor's office for COMAR technical cleanup.

ITEM 6 Work Force Group:

ITEM 8 Credentialing:

8(a). Washington County Health Department, MDH Classification and MDH Recruitment gave a presentation to the Board for the purpose to enhance the recruitment and application process that they interview applicants prior to the Board issuing a Certificate of Eligibility. The Board was open to the local jurisdictions interviewing applicants but not hiring until the applicant applies with the Board and receives the Certificate of Eligibility. Proposed language to allow this change will be submitted by Department of Budget Management for the Board's review and vote.

8b). The August 18, 2017 NEHA exam had 17 eligible candidates. 13 candidates sat for the exam. 4 candidates passed the exam. The passing candidates are listed below:

The Board requested that the applicant provide the exam she had taken in W. Virginia and the the Berkley County Health Department's Sanitarian job description with blank inspection forms for the various types of inspections she had identified in her letter. The requested documentation was provided however the Board Counsel advised the Board that an electronic vote would violate the Open Meetings Act, therefore this item will be placed on the December 6, 2017 Board Agenda.
