INTRODUCTION

The Annual Synar Report (ASR) format provides the means for states to comply with the reporting provisions of the Public Health Service Act (42 U.S.C. 300x-26) and the Tobacco Regulation for the Substance Abuse Prevention and Treatment Block Grant (SABG) (45 C.F.R. 96.130 (e)).

How the Synar report helps the Center for Substance Abuse Prevention

In accordance with the tobacco regulations, states are required to provide detailed information on progress made in enforcing youth tobacco access laws (FFY 2020 Compliance Progress) and future plans to ensure compliance with the Synar requirements to reduce youth tobacco access rates (FFY 2021 Intended Use Plan). These data are required by 42 U.S.C. 300x-26 and will be used by the Secretary to evaluate state compliance with the statute. Part of the mission of the Center for Substance Abuse Prevention (CSAP) is to assist states¹ by supporting Synar activities and providing technical assistance helpful in determining the type of enforcement measures and control strategies that are most effective. This information is helpful to CSAP in improving technical assistance resources and expertise on enforcement efforts and tobacco control program support activities, including state Synar program support services, through an enhanced technical assistance program involving conferences and workshops, development of training materials and guidance documents, and onsite technical assistance consultation.

How the Synar report can help states

The information gathered for the Synar report can help states describe and analyze substate needs for program enhancements. These data can also be used to report to the state legislature and other state and local organizations on progress made to date in enforcing youth tobacco access laws when aggregated statistical data from state Synar reports can demonstrate to the Secretary the national progress in reducing youth tobacco access problems. This information will also provide Congress with a better understanding of state progress in implementing Synar, including state difficulties and successes in enforcing retailer compliance with youth tobacco access laws.

¹The term "state" is used to refer to all the states and territories required to comply with Synar as part of the Substance Abuse Prevention and Treatment Block Grant Program requirements (42 U.S.C. 300x-64 and 45 C.F.R. 96.121).

The ASR must be received by SAMHSA no later than December 31, 2020 and must be submitted in the format specified by these instructions. Use of the approved format will avoid delays in the review and approval process. The chief executive officer (or an authorized designee) of the applicant organization must sign page one of the ASR certifying that the state has complied with all reporting requirements.

The state must upload one copy of the ASR using the online WebBGAS (Block Grant Application System). In addition, the following items must be uploaded to WebBGAS:

- FFY 2021 Synar Survey Results: States that use the Synar Survey Estimation System (SSES) must upload one copy of SSES Tables 1–8 (in Excel) to WebBGAS. Merchant education and/or training

PHPA developed merchant education materials, the "Responsible Tobacco Retailer Toolkit – '21 or None'," that outlines a clear understanding of the state law governing tobacco sales in retail outlets. There is an online retailer training module, where merchants can test their knowledge of the law and obtain additional tips to train employees. All local health departments conduct store-to-store educational visits to tobacco outlets to ensure they know the law and staff are continuously trained.

For the safety and health of Marylanders during the COVID-19 pandemic, the Governor issued a stay-at-home order and the closure of non-essential businesses that significantly impacted tobacco education, training, and enforcement activities.

In State Fiscal Year 2020 (July 1, 2019- June 30, 2020) 4,714 face-to-face store visits were conducted by local health departments and non-governmental partners to provide verbal education on youth access to tobacco products and state and local laws. As a result of COVID-19 the numbers are lower than previous years.

Incentives for merchants who are in compliance (e.g., nonenforcement compliance checks in which compliant retailers are given positive reinforcement and noncompliant retailers are warned about youth access laws)

Some local jurisdictions publish the name of compliant tobacco outlets in newspapers, website and provide certificates. Prior to COVID-19, some jurisdictions held award ceremonies.

Community education regarding youth access laws

Forty-eight leadership meetings were held with community partners, police agencies, local community action agencies and political leaders to discuss youth access laws with 633 attendees. Seventy-four school-based collaborations were held with school administrators, teachers, and parents to raise awareness about youth access to tobacco products with 7,143 attendees.

Media use to publicize compliance inspection results

Some local jurisdictions publish the names of compliant tobacco outlets in newspapers, provide certificates. Prior to COVID-19, some held award ceremonies.

Community mobilization to increase support for retailer compliance with youth access laws

Multiple non-governmental organizations partnered with local health departments to increase support and enhance discussion about youth access to tobacco products.

At the state and local level, media campaigns are conducted in a variety of venues to support state and local efforts.

Maryland's "21 or None" campaign and accompanying educational materials are currently being updated for distribution to licensed tobacco retailers (as well as vape shops) and include the Maryland Comptroller's Office's efforts regarding disposables

All local civil and criminal tobacco sale violations are reported to the Maryland Office of the Comptroller bi-annually. The Comptroller's Office, in turn, schedules hearings for repeat violators and issues additional sanctions as appropriate. These activities are reported annually to the Maryland General Assembly (state legislative body). The Maryland Department of Health maintains robust tobacco enforcement and education efforts that include local funding for compliance checks, education, media and online training for tobacco retailers. The Maryland Department of Health also reports to the General Assembly annually on all strategies and efforts to support existing tobacco sales laws.

Maryland's Tobacco 21 law took effect on October 1, 2019. Local jurisdictions had been planning for this change in the law and were prepared to enforce it. The state's "21 or None" campaign and accompanying educational materials are sent to licensed tobacco retailers, as well as vape shops and include the Maryland Comptroller's Office's efforts regarding disposables.

In February 2020, Maryland Comptroller Peter Franchot announced a first-in-the-nation approach to prohibiting the sale of certain Electronic Smoking Devices marketed toward youth. The Comptroller's Field Enforcement Division issued a directive to prioritize enforcement actions against unauthorized products most widely used by youth, specifically cartridge-based *and disposable* ESDs with flavors other than tobacco or menthol.²

In addition to the FDA's prohibition of flavored e-cigarette cartridges, the Comptroller directed that enforcement agents take more aggressive action by prohibiting the sale of disposable ESDs with flavors other than tobacco or menthol. Under Business Regulation §16.7-207(a)(5), retailer licenses to sell tobacco and ESD products in Maryland may be subject to disciplinary action if

Maryland did not conduct Synar inspections during this reporting period due to the COVID-19 pandemic. The Synar survey inspection period was scheduled in advance for April-September (as has been the case historically for Maryland), which was at the height of the pandemic. To protect the health and safety of Marylanders, Governor Hogan issued a number of executive orders, including the closure of non-essential businesses, stay-at-home orders for residents, encouraging teleworking, and reassignment of state employees to COVID-related activities.

Complying with the Governor's directives and safety concerns (close-quarter seating of adult and youth inspectors while riding in the vehicles, PPE precautions, general social distancing with the public, exchanging IDs between clerk/youth, wearing a mask while providing photo ID, etc.), Maryland suspended Synar all survey inspections for FFY 2021.

Following the Governor's updated directives in relation to the COVID-19 pandemic and following CDC guidelines, Maryland will determine if and when it is possible to move forward with conducting inspections during the next Synar inspection survey period.

The youth inspector must be in sight of the adult inspector at all times. The youth must not engage in any activities that would distract the adult from the ability to safely operate the vehicle.



Adult inspectors and youth inspectors will carry appropriate Maryland State identification. Synar inspections will be performed using the protocol below (all inspections will be consummated). Youth inspectors will be 16-18 years of age. They will work an average of 20-32 hours per week. Each youth inspector is assigned a three-digit identification number to conceal their identity.

The adult inspectors will pick up the youth inspectors at home or with written parental consent from school and proceed to the first of several tobacco outlets to be inspected for the day. The adult inspector will park in a safe inconspicuous space, and prior to entering the outlet, provide the youth inspector with money should the inspection result in a buy. If it has been determined that the outlet is safe, the youth inspector and the adult inspector will enter the outlet separately. If the adult inspector cannot accompany the youth into the outlet, the adult inspector must have the youth inspector in clear view at all times. If an outlet appears to be unsafe, the youth inspector will not be permitted to enter the outlet. The safety and protection of the youth inspector is of the utmost importance; therefore, they are in sight of the adult inspector at all times. The adult inspector will enter right before or right after the youth inspector so as to be close enough to hear and observe the attempted buy. If the clerk asks for the youth inspector's identification, the youth inspector will provide their state (MVA) issued identification. If the clerk asks them their age, they will provide their real age. Once the inspection has been completed, they will return to the vehicle. If a purchase is made, the youth inspector will hand over all the remaining money and tobacco product(s) to the adult inspector. The adult inspector will complete the inspection form as per Synar Program protocol. The youth inspector will complete a Synar Program attestation form to verify sale. Once the adult inspector has completed the inspection form, they will proceed to the next location until all inspections have been completed for that day.

When the inspections are completed, the adult inspector will drop the youth inspector off at home. The youth are not permitted to be dropped off any place other than their home. The completed inspection forms are delivered to the Synar program administrator for analysis. The data will be entered into an excel spreadsheet and uploaded into the Synar Survey Estimation System software (SSES).
