

## **CIT Implementation Progress Summary - FY15**

### **Jurisdictions with CIT Implemented**

- Howard County - min. of 2 trainings/year; trained 2 officers from Washington County; may expand CIT to Corrections Dept. HCPD began deploying CIT officers to assure shift coverage. Added crisis beds to crisis continuum & second MCT.
- Harford County- consulted with Carroll County and helped start training there.
- Baltimore County - longstanding model being reviewed
- Baltimore City - adopting AA County model, 70 trained this year, 2 attended CIT Conf., BH CIT Coordinator located at Academy
- Montgomery County - trained 60 officers; CIT Coord. won CIT Officer of the Year at CIT Conf.
- Wicomico/Somerset Counties - trainings began in Fall, 2014 - to date 39 LE and Corrections officers trained.
- Anne Arundel County - worked with Montgomery, Harford, & Howard for training; established model to target specific populations.
- Carroll County - NAMI president & CIT Coord. attended CIT Conf.. On-going consultation with Harford County. 7 officers from Westminster Police, 2 from Manchester PD, 1 from McDaniel College, 1 from Corrections trained. Plan to train 16 officers from Sheriff's Dept. in next 12 months to have 24 hr. coverage.
- Worcester County - partnering with Wicomico to share training. 8 officers trained & 2 dispatchers.
- Frederick County - both an LE & BH CIT Coordinator; trained 6 in Frederick County PD & 10 in Sheriff's Office. Training to be done with Police Academy. Added a walk-in component to crisis continuum.

### **Jurisdictions with CIT Implementation in Process**

- Cecil County - partnering with Mid-Shore to maximize resources; no designated CIT officers - training folded into tactical training.
- Allegany County - one officer attended CIT training in another jurisdiction, 2 attended National CIT Conf., 10 trained in MHFA
- Midshore - CIT Coordinator hired - presented at CIT Conf. 40 hour training to begin in May.
- Prince George's County -commitment secured from Chief of Prince George's PD, Sheriff, Director of Public Safety & several municipal depts. CPIC now meeting. LE sent to trainings in Howard County, Montgomery County, and Wicomico County. Have done a 4 hour training resulting in LE now wanting 40 hr. training.
- Washington County - City & Sheriff's Office have officers trained in MHFA with all officers to be trained by the end of FY15. Officers trained in Montgomery & Howard Counties. CIT Coordinator hired. MCT contract to be awarded during FY15.

### **Jurisdictions with CIT Implementation Challenges**

- Southern MD - Charles, St. Mary's, & Calvert Counties - difficulty getting buy-in from law enforcement. New Sheriff elected - waiting to see what the impact will be on possible partnership. No CIT Coordinator. LE & BH reps attended CIT Conf. St. Mary's Sheriff's Office sent deputies thru training in Montgomery County.

- Garrett County - difficulty engaging multiple law enforcement agencies in FY 14, but following Western CIT Forum, secured commitment from Oakland City Police, Garrett County Sheriff's Office, & State Police. 4 MHFA trainings to be done from March - May 2015.
