Mobile Crisis Response and Stabilization Services (MCRS)

Mobile Crisis responders provide in-person support to people when they experience a serious mental health or substance use challenge, including any crisis as the person defines it. These teams respond out to wherever the individual is in the community — such as their home, school, or other public place. Services are provided to de-escalate whatever is going on, evaluate the individual's behavioral health, stabilize the situation, and make connections to treatment and support services. Assertive Community Treatment (ACT)

Assertive Community Treatment is a multidisciplinary, team-based service delivery model that provides time-unlimited, community-based services for individuals with serious mental illness who experience or are at particular risk for concurrent substance use, frequent hospitalization, homelessness, involvement with the criminal legal system, and psychiatric crises. The primary goal is to help individuals achieve recovery through community treatment, rehabilitation, and support. Individuals participating in the program have access to services during regular business hours and providers are on call 24/7. To initiate a referral, reach out to the relevant team in the table below at the contact number listed.
