Welcome and Introductions

Commission Chair Cubbage welcomed all attendees to the Commission meeting. Commissioners introduced themselves.

Approval of November 20, 2019 Minutes

No corrections were made to the minutes. Minutes were approved.

Health Education and Suicide Prevention Pre-K - 12

Lea Jaspers of the Maryland State Department of Education (MSDE) presented to the Commission about the health education framework developed by MSDE. The existing framework outlines skills and core concepts that must be taught in health education classes, as well as the grade levels that topics must be introduced. The topics of mental illness, depression, and suicide must be first taught by eighth grade and then again in high school. Students will learn to identify warning signs and resources for depression and suicide and apply strategies and skills to respond to these concerns. MSDE is currently drafting a new framework for schools to respond to more recent concerns facing today's youth, such as bullying and issues facing the LGBT community. The new framework will also provide for schools to introduce many health concepts earlier than the existing framework requires. Commissioners made suggestions to consider social media, anxiety, stress, trauma, self-esteem and body image, and safe firearm storage in the new draft.

Behavioral Health Administration (BHA) Updates

BHA's new online training module, Suicide Prevention for Clinicians: Risk Assessment and Management Techniques, launched on January 10. The module can be found at mdbehavioralhealth.com/training.

State Suicide Prevention Plan

Commissioners were reminded that the first rough draft of the State Suicide Prevention Plan is due to Commission Chair Cubbage and Commissioner Drushel-Williams by January 31. Commissioners who do not think they can meet this deadline should inform Commission Chair Cubbage as soon as possible.

Training Workgroup Update

Commissioner Treger provided updates for the Training Workgroup. The Training Workgroup prioritized primary care physicians (PCPs) as the first group on which to focus their efforts. The Workgroup recommended that all PCPs, be trained in an evidence-based suicide prevention training program which includes screening for suicide risk, brief interventions, and providing appropriate referrals to services. This training should also provide CMEs to increase PCP buyin. The Workgroup also plans to recommend the creation of a new policy that would require



PCPs to receive a designated number of hours of suicide prevention training, but intends to ask PCPs for their feedback before proposing this recommendation. The Workgroup plans to hold regional meetings to obtain feedback on training recommendations, providers' attitudes and biases about suicide, and barriers to screening. The focus groups will consist of large practices and will help identify targeted groups for trainings and targeted groups to administer screenings, as well as proponents to champion the Workgroup's efforts among physicians and within professional organizations. BHA is planning to train physicians in the American Association of Suicidology's Recognizing and Responding to Suicide Risk: Essential Skills in Primary Care.

Physician Public Awareness Campaign Mockup

Mockups for the first three tiers of the campaign were reviewed. BHA is currently in discussion with their Communications office before rolling out the campaign. BHA is also creating a toolkit for the campaign, which will include suicide risk screeners, information on how to bill for screening, and information on how to implement screenings into practice.

Means Safety Workgroup Update

Commissioner Kulp provided updates for the Means Safety Workgroup. The Workgroup, in conjunction with the Training Workgroup, has spoken with Dr. Wintersteen, who developed the Pennsylvania Youth Suicide Prevention in Primary Care (YSP-PC) model. The YSP-PC model focuses on engaging PCPs in rural communities to effectively screen for suicide risk through the creation of local stakeholder groups, improved collaboration between medical and behavioral health providers, the provision of suicide assessment training to PCPs and suicide intervention training to therapists, and the provision of a web-based screening tool for providers. Dr. Wintersteen's lessons learned will inform the efforts of both workgroups moving forward.

The Means Safety Workgroup is also currently identifying partners for implementation of their recommendations. Local police departments have expressed interest in receiving and disseminating gun locks, but the Workgroup is seeking additional partners for gun lock dissemination, as well as opportunities to promote the online training, *Counseling on Access to Lethal Means*. The Workgroup has also contacted the Maryland Licensed Firearm Dealers Association and New Hampshire's Gun Shop Project for guidance on appealing to firearm communities about safety and responsible ownership. They plan to conduct focus groups to learn more about firearm owners' perceptions and practices around safety. The Workgroup is pursuing avenues to raise awareness of Extreme Risk Protective Orders (ERPO). Of note, the Maryland Chapter of the National Association of Social Workers is hosting a three-hour ERPO training in the spring. Additionally, the Commission has partnered with the Education Fund to Stop Gun Violence to administer a survey of clinicians' familiarity and use of ERPOs. The vast majority of the responses received to date have indicated little awareness of ERPO petitions.



Data Workgroup Update

Commissioner Lavetsky provided updates for the Data Workgroup. The Environmental Public Health Tracking (EPHT) portal is slated to be updated with more recent data about suicides. A content page about suicide to include on the EPHT is currently in development. The content page will provide information on suicide risk, warning signs, and how to intervene. The Workgroup also plans to present data tables and graphs using 2017 suicide data from the Maryland Violent Death Reporting System (MVDRS) to the Commission. The Workgroup also plans to utilize other sources of morbidity data on intentional self-harm and will create and disseminate data products.

Suicide Fatality Review Workgroup Update

Dr. Lanny Berman provided updates for the Suicide Fatality Review Workgroup. Dr. Berman has contacted other states who have attempted to implement suicide fatality review teams. Dr. Berman first spoke with Garra Lloyd-Lester, Director of Suicide Prevention in New York. New York has funded a pilot project in four counties through the American Foundation of Suicide Prevention. Their pilot project is limited to the use of publicly available epidemiological data sources only, which often do not provide information on other circumstances, such as sleep disturbances, that are relevant to suicide risk. Dr. Berman has also contacted Kim Repp, an epidemiologist from Oregon. Oregon has implemented a suicide fatality review team in one county. 30 organizational representatives provide data on individual cases. Dr. Berman also spoke to Misty Leitsch, Interim Director of the Tennessee Suicide Prevention Network. She advised that Tenessee previously proposed legislation to establish a statewide suicide fatality review team, but the statue was stalled and evolved into the development of a state suicide prevention coordinator position. Dr. Berman has adapted Tennessee's legislation for Maryland and has submitted it Commissioner Eckhardt for comment. Dr. Berman also plans to speak to Maryland's Child Fatality Review Teams and Overdose Fatality Review Teams for potential overlap and collaboration, as well as brainstorm potential data sources that go beyond the MVDRS data.

Commission Business Cards

Commissioners will not be required to have business cards, but may have them if interested. The front of the card will have the Commissioners' name printed on it. Commissioners suggested providing crisis information on the back of the business card. Commissioners interested in having business cards should contact Commission Chair Cubbage so that a quote for printing may be established.

The Washington Post had an article on the rising rates of workplace suicides on January 14, 2020. The Congressional Black Caucus recently released a report to Congress titled, *Ring the Alarm: The Crisis of Black Youth Suicide in America.* MSDE is also holding their annual training for all school-based suicide prevention points of contact. Commission Vice Chair Wilcox and Brandon Johnson of SAMHSA will be presenting.
