Change of Address Forms

It is the responsibility of the licensee to report to the Board any change of name or address to the Board within 30 days after that change. The change of address form will no longer be printed on newsletters—the change of address form is available on the Board's website in the "Forms" section. To change your name you must mail a copy of the official document with your correspondence. If you request a new license reflecting the name and/or address change you must submit a \$5.00 fee for each license printed.

Revised Laws and Regulations Books Distributed

In August 2009 laws and regulation books were distributed to all active licensees. The revised laws and regulations books are the culmination of years of hard work in amending the statute and implementing regulations for the three professions governed by the Board. The Board would like to take this opportunity to remind licensees that it is their responsibility to know and understand the laws and regulations governing their profession. Questions regarding the laws and regulations governing the three professions may directed to the Board staff. Board staff may require an individual to submit a written petition to the Board for clarification of any inquiry.

H1N1 Update

All health care practitioners have an obligation to ensure the health of their patients and clients with the practice of good personal and workplace hygiene. This includes this year's effort to contain the H1N1 (swine) virus. The Maryland DHMH has encouraged everyone, including all health care practitioners, to assist in broad-based efforts to prevent the spread of the H1N1 virus. Health practitioners should redouble their efforts to ensure a clean work environment for the benefit of patients, clients, and staff. Guidance on the subject of containing the H1N1 virus changes often as more is learned about this particular virus strain every day. Renewal 2010

Audiologists and speech-language pathologists may renew their licenses in April/May 2010. Renewal notices will be mailed in March 2010. On-line renewal will once again be available as an effective, timely means to renew a license. On-line renewal of a license is strongly encouraged and recommended. Renewal notices will contain specific information regarding the renewal process, renewal fees, CEU audit requirements, and other relevant information.

Renewal—Back Taxes and Child Support

State law prohibits the Board from issuing a renewal license unless all back taxes are paid or a plan is in place to pay back taxes. Additionally, State law requires that all court-ordered child support payments be current; in fact, a license is subject to suspension if court-ordered child support payments are not current. The Board is cooperating with efforts taken by Social Service departments to ensure that all court ordered payments are current.

Important Continuing Education Information

Although this information appeared in the Spring/Summer 2009 AHS News it is repeated here due to its impact on audiologists and speech-language pathologists qualifying for renewal.

Effective June 1, 2008 CEUs must be earned on a calendar year basis. For the current license renewal period of June 1, 2008 through May 31, 2010 licensees with a single license in audiology or speech pathology must earn at least 15 CEUs by December 31, 2009; the Board had determined that at least 10 CEUs must be earned in the area of licensure and at least 5 CEUs must be earned in related subjects.

Licensees with dual licensure in audiology and speech-language pathology must earn at least 25 CEUs by December 31, 2009; the Board has determined that at least 10 CEUs must be earned in each area of licensure and at least 5 CEUs must be earned in related subjects in either discipline.

For this renewal cycle only the Board has reduced the number of CEUs required to qualify for renewal to accommodate the shortened timeframe to earn CEUs to qualify for renewal. Please note that licenses will continue to expire every two years on May 31 of even numbered years as is currently done.

In subsequent licensure periods licensees with one license must earn at least 20 CEUs and licensees with two licenses must earn at least 30 CEUs.

Licensees who were issued their initial license from June 2008 to November 2009 are subject to the prorated CEU requirements. For more information regarding the prorated CEU requirements and the specific number of CEUs required please see page 4 of this newsletter. New licensees should review the prorated CEU requirements to be earned to qualify for renewal and plan accordingly. New licensees may utilize the on-line license verification feature to determine when their license was issued to determine the number of CEUs that must be completed to qualify for renewal.

Licensees who are issued a license during December 2009 through May 2010 are exempt from the CEU requirements to qualify for renewal.

Prorated CEU Requirement for 2010 Renewal for New Audiology and New Speech-Language Pathology Licensees

The following chart indicates the number of CEU hours to be completed by Audiology and Speech-Language Pathology licensees with licenses issued from June 2008 through November 2009.

Single License applies to an individual holding an Audiology license or a Speech-Language Pathology license originally issued in the months listed. Dual License applies to an individual holding an Audiology license and a Speech-Language Pathology license if both of those licenses were originally issued in the months listed.

Individuals who have a single license and were originally issued their initial license during or after December 2009 are exempt from the CEU requirements to qualify for renewal in 2010.

Individuals who have a single license issued during May 2008 or earlier are required to complete the full 15 CEUs to qualify for renewal for the 2010 - 2012 cycle.

Individuals who have dual licensure with at least one license issued during May 2008 or earlier are required to complete the full 25 CEUs.

All CEUs must be completed by December 31, 2009 to qualify for renewal in 2010. To qualify for renewal in 2012 all licenses must meet the CEU requirements specified in COMAR 10.41.03.06.

Disciplinary Matters

Mitchell Stein, Hearing Aid Dispenser, Order Lifting Probation issued June 21, 2009. License restored without restrictions or conditions.

Asher Elkayam, Hearing Aid Dispenser, Consent Order issued August 7, 2009. License suspended for one year, stayed; probation for two years with conditions.

E-Newsletter

Due to budget cutting measures at the State level that have affected all units of government the Board has voted to produce and distribute electronic newsletters. Newsletters will be posted to the Board's website and licensees will be notified of the new newsletter via e-mail (the e-mail will be sent to the e-mail address on file with the Board). For this newsletter only an abbreviated, courtesy black & white hardcopy was sent only to those active licensees that have not yet submitted a valid e-mail address to the Board. All subsequent newsletters will only be posted to the Board's website with an e-mail sent to each licensee to inform the licensee of the new newsletter. The Board advises that it is the licensee's responsibility to keep the Board informed of any change to e-mail addresses. E-mail addresses will not be shared with any individual/group or used for any other purpose than to communicate relevant news and information to licensees.

State Furloughs

The Board will be affected by furloughs in fiscal year 2010; the Board was also previously affected by furloughs in fiscal year 2009. Board staff and the personnel that provide essential support functions (legal, regulatory, fiscal, and information technology) are affected by the new furloughs imposed in FY 2010. However, unlike the furloughs imposed in FY 2009, the funds saved by the furloughs in FY 2010 will be transferred to the General Fund. In addition to traditional holidays the Board's offices will also be closed on the following days: November 25, 2009, December 24, 2009, December 31, 2009, and May 28, 2010 – these days precede regular State holidays and are intended to minimize impact on conducting State business. In addition to the mandated State closure days Board staff will be required to take other furlough days according to their compensation level. Board staff will endeavor to minimize the negative impact of the loss of transferred funds and the impact the mandated furlough days on the Board's daily operations. The State's anticipated budget deficit of \$2 billion in FY 2011 will most likely impact and affect State business and activities next year as well.

Statistical Report

As of October 1, 2009 there were 2,813 Speech-Language Pathologists, 36 Speech-Language Pathology Assistants, 395 Audiologists, 114 Hearing Aid Dispensers with active licenses in Maryland. In addition to the active licensees, the Board has 113 Speech-Language Pathologist—Limited license, 36 Speech-Language Pathologist Assistants-Limited License, and 3 Hearing Aid Dispensers-Limited Licenses.
