PRE-CHARGE CONSENT ORDER

PROCEDURAL BACKGROUND

The Maryland State Board of Morticians and Funeral Directors (the "Board") and Cedar Hill Funeral Home, Inc. (the "Respondent"), license number C00028, have agreed to enter into this Pre-Charge Consent Order (the "Order") in lieu of the Board's filing formal charges for violating provisions of the Maryland Morticians and Funeral Directors Act ("the Act"), Md. Code Ann., Health Occ. ("H.O.") §§ 7-101 et seq. (2009 Repl. Vol.), specifically H.O. § H.O. 7-316(a)(5) and (26), for aiding and abetting the unauthorized practice of mortuary science and for unprofessional conduct in the practice of mortuary science.

The Board initiated an investigation of the Respondent's funeral home, Cedar Hill Funeral Home, Inc., license number E00353, 4111 Pennsylvania Avenue, Suitland Maryland, upon receipt of a complaint from Complainant A¹ (the "Complainant") who had contracted with the Respondent to provide funeral and burial services for her deceased son.

A Pre-Charge Complaint Resolution Conference (CRC) took place on July 11, 2012.

Participating were the Respondent's representatives and a panel of Board members (the "CRC Panel"). Prior to the CRC, Respondent had initiated its own internal investigation and had already

substantially corrected the issues which were before the CRC Panel. Further, Respondent had cooperated fully in the Board's investigation.

On January 30, 2012, at the request of the Board and Complainant A, Respondent disinterred the remains of Complainant A's deceased son, which were immediately re-interred to a location chosen by the family on the perimeter of the mausoleum. In addition, at the request of the Board and Complainant A, the Respondent, on or about January 31, 2012, refunded the amount of Five Thousand Eight Hundred and Fifty One Dollars (\$5,851.00), which comprised the contract price of the funeral for the deceased son of Complainant A.

The Board's authority to investigate and charge the Respondent is derived from H.O. § 7-205(a)(5).

FINDINGS OF FACT

- Unlicensed individual ² employed by the Respondent's funeral establishment made arrangements with complainant A for funeral services and burial of her deceased son.
- The unlicensed individual told Complainant A that it was her responsibility to go to the deceased's doctor in order to have the doctor sign the certificate of death.
- 3. The funeral service and interment were not conducted in an appropriate manner.
- Only Complainant A and few of the family members gathered for the interment were allowed to attend the interment in an inaccessible lower mausoleum.
- Complainant A and those family members allowed to attend the interment were transported in the private vehicle belonging to an employee of the Respondent that was littered with trash
- Upon inspection in December 2011, the inspector found no supervising mortician license on display.

 Complainant B³ was told by Respondents employee(s) that she would not be given the certificate of death until she paid her funeral bill.

CONCLUSIONS OF LAW

Based on the foregoing Findings of Fact, the Board finds that the Respondent aided and abetted the unauthorized practice of mortuary science and acted unprofessionally in the practice of mortuary science in violation of H.O. §§ 7-316(a)(5) and (26).

ORDER

ORDERED that the Respondent shall, within 120 days form the effective date of this Order, document to the Board that it has provided pro-bono funeral services fairly valued at five thousand dollars (\$5000.00); ⁴ and it is further

ORDERED that within 90 days from the effective date of this Order, the Respondent shall pay a fine the Board in the amount of three thousand dollars (\$3000.00); and it is further

ORDERED that for one year following the entry of this Order, the Board may, in its discretion, make periodic unannounced inspections of Respondent's funeral home located at 4111 Pennsylvania Avenue, Suitland Maryland; and it is further

ORDERED that any violation of the terms and conditions of this Order, including but not limited to an individual's failure to cooperate with the Board's investigator or inspector shall result in immediate suspension of the Respondent's Maryland Corporation license without prior notice or an opportunity to be heard, provided it is given the opportunity for a show cause hearing before the Board and after notice and a hearing, and a determination of a violation, the Board may impose any other disciplinary sanctions it deems appropriate, including but not limited to revocation or suspension, said violation be proven by a preponderance of the evidence; and it is further

ORDERED that the Respondent shall reasonably cooperate with the Board's investigation of activities relating to the aforementioned Complaint Numbers and the individuals referenced in those complaints, by, among other things, providing such relevant documents in the Respondent's files (or those of its related entities) as are reasonably requested by the Board, and which cooperation and provision of documents is subject to the following express understandings: (i) that such relevant documents in the Respondent's files (or those of related entities) as are reasonably requested by the Board may be redacted as necessary in the Respondent's discretion to remove the Respondent's customers' identifying information and (ii) that none of the Respondent's customers (except the Complainants who initiated the aforementioned complaint Numbers) shall be contacted by the Board or its representatives without prior consent of the Respondent, which shall not be unreasonably withheld; and it is further

ORDERED that if the Board's investigator or inspector believes that the Respondent is not properly cooperating with the Board's investigation, and the Board's representative is not able to informally resolve the issues with the Respondent, the Board shall deem the Respondent's failure to cooperate to be a violation of this Order, subjecting the Respondent to potential further disciplinary action before the full Board; and it is further

ORDERED that this Order resolves the Complaint Numbers captioned above; and it is further;

ORDERED that this Order is a PUBLIC DOCUMENT as defined in Md. State Gov't Code Ann. §§ 10-611 et seq. (2009).
