- E. Apprenticeship license, renewal fee ... \$325;
- F. Corporation license, renewal fee ... \$975;
- G. Establishment license, initial fee ... \$700;
- H. Establishment license, renewal fee ... \$700;
- I. Funeral director license, initial fee ... \$600;
- J. Funeral director license, renewal fee ... \$600;

#### **.08 Fees.**

The following fees are established by the Board:

##### A. Initial permit or registration and renewal fees:

- (1) Crematory permit — [~~\$350~~] *\$450*;
- (2) Registered crematory operator — [~~\$300~~] *\$350*;
- (3) Crematory permit renewal — [~~\$350~~] *\$450*;
- (4) Registered crematory operator renewal — [~~\$300~~] *\$350*; and
- (5) Late fee — \$200; and

##### B. Miscellaneous fees:

- (1) Replacement of permit or registration — \$50;
- (2) Returned check fee — \$50;
- (3) Duplicate permit or registration — \$50;
- (4) Business name change — \$50;
- (5) Personal name change — \$50;
- (6) Business address change — \$50; and
- (7) Annual pre-need sales trust report — \$25.

## 10.29.21 Mortuary Transport Services

Authority: Health-Occupations Article, §§7-101 and 7-601—7-607, Annotated Code of Maryland

### .08 Fees.

The following fees related to mortuary transport services are established by the Board:

#### A. Mortuary Transport Service Permit:

##### (1) Initial fee:

- (a) Category 1 (for 1—3 transporters, including the permit holder) — [~~\$350~~] *\$400*;
- (b) Category 2 (for 4—7 transporters, including the permit holder) — [~~\$500~~] *\$550*;
- (c) Category 3 (for 8—15 transporters, including the permit holder) — [~~\$750~~] *\$800*; and
- (d) Category 4 (for more than 15 transporters, including the permit holder) — [~~\$1,000~~] *\$1,050*; and

##### (2) Renewal fee:

(a) The permit renewal fee shall be the same as the initial fee provided there has been no change in category;

(b) If the number of transporters employed by a mortuary transport service has increased, resulting in a change in category, the initial fee for the higher category shall be paid as the renewal fee; and

(c) If the number of transporters employed by a mortuary transport service has decreased, resulting in a change in category, the initial fee for the lower category shall be paid as the renewal fee;

B. [Transporter] *Biennial transporter* registration processing fee (to add a transporter without change of category within the renewal cycle) — [~~\$40~~] *\$75*;

C. Late fee (permit) — \$400;

D. Reinstatement fee — \$350 + initial fee;

E. Duplicate or replacement permit — \$40;

F. Duplicate registration — \$50;

G. Permit or registration verification fee — \$40; and

H. Replacement inspection sticker — \$40.
