Legislative and Regulatory Changes

The Board has been very busy with promoting the promulgation of new and/or amended laws and regulations that will directly impact the LNHA Community and better serve and protect the public. Following are some important changes to be aware of:

Criminal History Records Checks

Senate Bill 109, Health Occupations Boards

- Criminal History Records Checks - Required, was passed by the Senate on February 12, 2016 and by the House on March 28, 2016. It was signed into law by Governor Hogan on April 12, 2016 and officially became effective as State Law on October 1, 2016. This new legislation (and all references to it) can be found at Health Occupations Article §§ 9-301(b)(3) through (6); 9-302(a)(1) and (2); 9-302.1; 9-303(3); 9-308(b)(1)(i) through (vii); 9-308(b)(2); 9-311(f)(1)(i) and (ii); 9-311(f)(2)(i) through (vii); 9-311(f)(3) and (4); 9-312.1(e)(5); and 9-314(b)(13).

The Board voted to implement this criminal history records checks process beginning on Tuesday, January 3, 2017. This law applies to all Administrator-in-Training applicants, new license applicants (i.e., endorsement applicants), provisional license applicants, and existing licensees (who will need to undergo the criminal history process upon their first license renewal).

If a licensee or applicant is currently licensed by another State of Maryland Health Occupations board, and has previously completed a criminal history records check with that board, he/she will not be required to do another criminal history records check. However, he/she is responsible for providing this Board with a verifiable copy of the criminal history records check.

When you are preparing to have

your criminal background check processed, please e-mail the Licensing Coordinator andrea.hill@maryland.gov or the Executive Director at ronda.washington@maryland.gov to request the Board's authorization number and its "Originating Agency Identifier" number ("ORI" number). You will need these two numbers to proceed with your background check being processed. For your convenience, the Criminal History Livescan Pre-Registration Application will be available on the Board's website at the "Forms" link for you to print out to take with you for processing.

Amended Regulation: COMAR 10.33.01.14- Certification of Preceptor

On October 20, 2016, the Board formally submitted a proposed amendment to this existing regulation. It was signed and adopted by Secretary Dennis Schrader on January 26, 2017, was published in its final form in the Maryland Register, Volume 44, Issue 4 on February 17, 2017, and became effective on February 27, 2017. This entire amended regulation may be accessed at http://www.dsd.state.md.us/comar/comarhtml/10/10.33.01.14.htm The Board, in consultation with several members of the LNHA Community, voted to amend its existing regulation. Many thanks to Glenn Scherer, Garret Falcone, and Merian Ritacco, who had a desire to serve as preceptors, but due to working as executive directors no longer met the regulatory criteria to serve. Additionally, special thanks go to Danna Kauffman of the LifeSpan Network for her input and work on this amendment, on behalf of her organization, in support of this regulatory change. The intent was to clarify and strengthen part of the existing regulation by adding the words "of record" to the standing requirement that a preceptor must have practiced as a nursing home administrator for two of the past three years immediately before submitting an application to serve as a preceptor.

The new language added to the regulation will allow many LNHA's, who have not served as administrators of record for many years and are currently serving in positions such as executive directors, to qualify to precept. The new language is as follows:

"...or (b) Meets the following qualifications:

(i) Works on the same property as the nursing home where the AIT program will be conducted and meets the standard in Regulation .02B(7)(b) of this chapter;

(ii) Is able to demonstrate to the Board the proposed preceptor's active, direct, and material management and daily operations of the nursing home; and

(iii) Has been actively licensed as a nursing home administrator for a minimum of 5 years immediately before application to precept."

Provisional Licenses for Non-licensed Persons

House Bill 145, Board of Examiners of Nursing Home Administrators—Non-licensed Persons– Provisional Licensure, was passed by the House on February 24, 2017 and was passed by the Senate on March 29, 2017. It was signed into law by Governor Hogan on April 11, 2017 and will officially become effective as State Law on October 1, 2017. This amended legislation can be found at Health Occupations Article § 9-301 "License required; exception." This is the statutory provision that allows a nursing home facility to appoint an interim administrator who is not an LNHA (e.g., the facility's DON). **This provision is for "unexpected cause" only**, meaning it will be approved by the Board in emergent and other situations in which there is no way for the facility to plan ahead to appoint an interim administrator of record who is an LNHA . Examples of unexpected cause are: death; sudden termination of employment; or a severe and sudden medical situation or accident that immediately incapacitates and thereby prevents the facility's LNHA of record from functioning in his/her role (as opposed to a planned maternity leave, a planned scheduled surgery, or a resignation with notice).

The Board promoted this amended legislation, because it corrects an inconsistency between its statute and the Code of Federal Regulations (42 CFR 431.710), which requires that all nursing homes be administered by a licensed nursing home administrator. The new law authorizes the Board to issue a provisional nursing home administrator license to an individual who the Board, in its discretion, determines to be of good moral character and capable of adequately administering the nursing home during the provisional period.

If the Board denies an application for a provisional license, the non-licensed person shall immediately cease acting as interim administrator and, if a licensed nursing home administrator remains unavailable, appoint another non-licensed person to act as interim administrator.

This law and new process will become effective as of October 1, 2017. The application for the provisional license will be available on the Board's website at the "Forms" link. There is no application fee or licensing fee for provisional licenses.

All applicants for provisional licensure must undergo a criminal history records check, unless they are currently licensed by another State of Maryland Health Occupations board and have previously undergone a criminal history records check with that board. If so, he/she is responsible for providing this Board with a verifiable copy of this criminal history records check.
