BLTCA is currently recruiting for 2 positions – Executive Director and Health Occupations Investigator II. Both are full-time permanent PIN positions. The Executive Director position has been posted onto the State of Maryland JobAps website and has closed. The Board is currently in the recruitment process for the Executive Director position. The Board will be notified once the new Executive Director has been chosen. The Health Occupations Investigator II position has been posted as of September 26th, 2023, and will close on October 30th, 2023.
