BOARD OF PROFESSIONAL COUNSELORS AND THERAPISTS

The Maryland State Board of Professional Counselors and Therapists (the "Board") functions under Health Occupations Article, Title 17, Annotated Code of Maryland. The Board is the licensure and certification authority of alcohol and drug counselors, art therapists, behavior analysts, marriage and family therapists, and professional counselors in the state of Maryland.

The Board is mandated to regulate these professions by verifying individuals' credentials, issuing licenses and certificates, establishing requirements for and verifying completion of continuing education hours, investigating complaints based on alleged violations of statutes and regulations, imposing formal and informal disciplining of licensees and certificate holders, establishing committees as deemed appropriate to advise the Board, and to submit an annual report to the Governor and Secretary.

ADMINISTRATIVE & OPERATIONAL SUPPORT

The Board has provided consistent administrative and operational support, including committee meetings, monthly Board meetings, Open Administrative meetings, document preparation such as meeting minutes, committee minutes. calendar management, document preparation, and coordination of communications to maintain efficiency, continuity, and to ensure smooth operations.

Board Meetings

During the year, the Board held 11 Open and Administrative Sessions Meetings. The Open Session meetings are open to the public. All Open and Administrative Sessions occur on the 3rd Friday of every month. The Board has coordinated and participated in regular Executive Director meetings to provide updates, share critical insights, and ensure organizational goals and strategic initiatives are aligned.

Committee Meetings

Credentialling Committee – The Board's Credentialing Committee meets once per month. The committee, composed of Board members and Board staff, performs a detailed review of applications and related information. The Credentialing committee, working with Board staff, manages the administrative side; ensuring that an agenda for meeting as well as documentation is complete and accurate prior to presenting.

The Credentialing committee ensures the credentialing process aligns with BOPCT's strategic goals. It ensures the credentialing process focuses on counselors and therapists to meet all necessary qualifications such as an applicant's competence, professional conduct and clinical skills to deliver patient care.

In addition, the Committee reviews contested matters, in cases of license denial, developing and updating the Board's credentialing policy and procedures, such as approving temporary license or allowing extensions.

Disciplinary Review Committee – The Board's Disciplinary Review Committee (DRC) meets once per month to address and review investigative findings on complaints filed. The Board staff determine legal sufficiency; ensuring evidence is factually and legally sufficient to support a charge of a violation of the practice or professional standards.

The Board staff is responsible for holding hearings; if a case proceeds, administrative hearings are conducted consisting of the board's legal counsel, the licensee, (or their attorney) can present evidence; call witnesses and make arguments, thus the Board makes the final determination as

well as recommendations such as imposing sanctions, imposing disciplinary actions in the form of public reprimands, fines, mandatory continuing education or probation, to more severe actions such as license suspension or revocation. These actions are brought before the full board to make the final determination.

Legislation & Regulation Committee (LEGS & REGS) – The Legislative liaison as well as committee are responsible for tracking bills introduced in state legislative which directly impacts the Board's authority in determining regulatory decisions in scope of practice, and requirements of licensure.

The Legs & Regs committee assess their proposed impact on public protection, board's operations in determining whether proposed bills align with the Board's mission and goals. In addition, the Board proactively drafts new legislative proposals or amendments to existing statutes to enhance consumer protection, as well as gather stakeholder input and recommendations.

Compliance & Investigations

Investigations division is tasked with intake and review of complaints. Compliance staff receive, review, and log complaints from the public, law enforcement, or other licenses. An investigator in the compliance unit reviews the initial complaint to

determine if it falls under the board's jurisdiction and warrants a full investigation. The Investigations division is also tasked to collect records and other relevant documents for a case by issuing subpoenas to facilities, practitioners, or other involved parties.

The Board received a total of 235 complaints in 2024. The Board issued formal disciplinary actions. All public disciplinary orders can be found on the Board's website at www.health.maryland.gov/bopc. The Compliance staff track and monitor licenses placed on probation or subject to consent orders, in addition to ensuring individuals fulfill all conditions, which can include continuing education, supervision requirements, drug or alcohol monitoring, or practice limitations.

Fiscal Operations

The Board is special funded. Revenues which support the Board's administrative and operational tasks are generated through licensing and certification fees. No other state funds can be used to support the Board's operations. In collaboration with appropriate fiscal authorities, the Board has ensured proper financial oversight by tracking budget

allocations, monitoring expenditures, and supporting procurement and reimbursement processes.

The Board generated **\$2,028,308.85** in revenues in 2024, and its expenditure totaled **\$1,330,512.51**
