2025 ONLINE RENEWAL NOTICE

PLEASE READ THE FOLLOWING CAREFULLY.

General Renewal Information:

The renewal portal for all licensees and certificate holders whose licenses expire on **January 31, 2025**, will open on **November 1, 2024**, and close on **January 31, 2025**. You may access the online portal by clicking on the “**License Renewal Portal**” link which will appear in both the center and right side of the Board’s homepage.

Continuing Education Requirements for Renewal- Please be sure you have completed your required continuing education (CE) hours for this renewal period. CEUs must be completed between **February 1, 2023 – January 31, 2025**.

Criminal History Records Check (CHRC)- As required in Health Occupations Article, §17-501.1, Annotated Code of Maryland, licensees must complete a background check if it has been 6 years or more since your last CHRC report. A complete CHRC includes both State and federal reports. The date of your last CHRC may be found on the Board’s website under “**License Verification**”. Maryland residents can use the link following to obtain and complete their CHRC, **<https://health.maryland.gov/bopc/pdfs/chrc.pdf>**

If you have completed your CHRC, please notify the Board via email at mail at **mdh.bopct@maryland.gov** within 3 days of completion so that your CHRC date can be updated in our database.

Out of State applicants who are up for renewal and need to complete a CHRC will need to contact the Board at 410-764-4732 to receive a fingerprint packet.

Renewal Fees- The cost to renew your license is \$301.00. The renewal fee must be paid by Credit/Debit card ONLY (Visa or MasterCard). Licenses that have not been renewed by midnight on January 31, 2025, will need to mail a paper reinstatement application along with a check/money order in the amount \$501.00 to reinstate your license after the deadline.

Implicit Bias Training Requirement:

MD Code Ann., Health Occupations Art. § 1-225

The law requires *all health care practitioners* in Maryland to attest that they have completed an implicit bias training program on their license renewal application.

At the time of renewal, you will need to have completed one of the implicit bias training courses approved by the Office of Minority Health and Health Disparities (MHHD). Please note the courses listed do not count towards your continuing education hours, but will satisfy the implicit bias training requirement for licensure renewal. You will attest to the completion of the training by checking the appropriate box in your renewal application. You are only required to attest to the completion of the training once. You will not need to repeat this attestation during subsequent renewals.
