ORDER OF TERMINATION OF PROBATION AND REINSTATEMENT

WHEREAS, on April 19, 2024, the Maryland State Board of Professional Counselors and Therapists (the “Board”) executed a Pre-Charge Consent Order of Reprimand (“Consent Order”) regarding CANDACE STRAND, License Number SC3238. The Consent Order placed the license to practice as a certified supervised counselor, alcohol and drug (“CSC-AD License”) in the State of Maryland on probation for one year (1) year.

WHEREAS, on or about July 17, 2025, the Board received petition to terminate the probation of CSC-AD License, License Number SC 3238; and

WHEREAS, on or about October 15, 2025, a quorum of the Board convened and considered the petition to terminate probation of the CSC-AD license; and

WHEREAS, the Board found CANDACE STRAND satisfactorily completed the conditions set forth in the Consent Order and voted to approve the petition to terminate the probation of the CSC-AD license.

It is therefore:

ORDERED, that the petition to terminate the probation of CANDACE STRAND’s license to practice certified supervised alcohol and drug counseling in the State of Maryland, under License Number SC3238, is **GRANTED**; and it is further

ORDERED, that CANDACE STRAND's license to practice certified supervised alcohol and drug counseling in the State of Maryland, under License Number SC3238 is **REINSTATED**; and it is further

ORDERED, that this is a Final Order of the Maryland State Board of Professional Counselors and Therapists and as such is a **PUBLIC DOCUMENT** which shall be posted to the Board's website pursuant to Md. Code Ann., Gen. Prov. Art. §4-333(b) (2019 Rep. Vol.) and Health Occupations Article § 1-607 (2019 Rep. Vol.)
