- 4. Complete the LiveScan Pre-registration Application and bring it to any fingerprinting center/provider.
- 5. Bring payment as indicated above. The Board will receive the results from the criminal history records check directly from CHS within 5-7 business days. The Board will contact you if it has any questions regarding the report. Please do not contact the Board to check if the report has been received.
- 6. Please do not send the LiveScan Pre-registration Application to the Board. You must present it at the fingerprint center/provider location.
