### **PRE-CHARGE CONSENT ORDER**

### Background

On or about March 22, 2019, the Maryland Board of Physical Therapy Examiners (the "Board") received an application from Katherine Bayer, DPT, to reinstate her license to practice physical therapy in Maryland, License No. 25195. On her application, Dr. Bayer stated that she continued to practice physical therapy after her license expired on May 31, 2017. In a follow-up email, Dr. Bayer stated that she practiced physical therapy on an expired license from June 1, 2017, to March 22, 2019, in her capacity as a physical therapist at a small home health company.

In lieu of instituting formal proceedings against Dr. Bayer in accordance with the Maryland Physical Therapy Act, Md. Code Ann., Health Occ. § 13-101 *et seq.*, the Board held a Pre-Charge Case Resolution Conference ("CRC") with Dr. Bayer on September 17, 2019. As a result, the Board and Dr. Bayer have agreed to resolve this matter as set forth in this Consent Order.

#### **FINDINGS OF FACT**

 Dr. Bayer was initially licensed by the Board to practice physical therapy under License No. 25195 on September 4, 2014. Her license is currently active and is set to expire on May 31, 2021.

- 2. On or about March 22, 2019, the Board received an application from Dr. Bayer to reinstate her license, which had expired on May 31, 2017. On her application, Dr. Bayer admitted that she had continued to practice physical therapy on her expired license. Dr. Bayer also sent an email to the Board taking responsibility for failing to renew her license and explaining that it was an embarrassing oversight. Dr. Bayer also stated that despite failing to renew her license she was up to date on continuing education, and clarified that she treated an average of less than 5 patients per week in Maryland.
- The Board reinstated Dr. Bayer's license to practice as a physical therapist on March 27, 2019.
- 4. In response to an April 1, 2019 email from the Board's Chief Compliance Officer, Dr. Bayer reiterated the information from her March 22 email and clarified that she practiced physical therapy on an expired license between June 1, 2017, and March 22, 2019, before she realized her license was expired. Dr. Bayer also stated that she believed she had renewed her license in Maryland at the same time as she renewed her licenses in Virginia and the District of Columbia at that she must have failed to properly complete her Maryland renewal application.
- 5. At the September 17, 2019 CRC, Dr. Bayer took full responsibility for practicing on an expired license and expressed remorse for letting it happen. Dr. Bayer explained that she believed she had properly renewed her license and had checked it off her to-do list. Dr. Bayer also noted that because she worked as an independent contractor, there was no office wall to post her renewed license on or employer to remind her to renew.

## **CONCLUSION OF LAW**

Based on the foregoing Findings of Fact, the Board concludes that Dr. Bayer is subject to disciplinary action in accordance with Md. Code Ann., Health Occ. §§ 13-401 and 13-407, and COMAR 10.38.10.06.

### ORDER

Based on an affirmative vote of a majority of the Board, it is this  $12^{7}$  day of Movember, 2019, hereby:

**ORDERED** that Dr. Bayer shall pay a fine in the amount of \$2,500, payable to the Maryland Board of Physical Therapy Examiners, within ninety (90) days of the date of the Order; and be it further,

**ORDERED** that failure to pay in full the above fine within ninety (90) days of the date of this Order shall be considered a violation of this Order, and after notice and opportunity for a hearing shall subject Dr. Bayer to further discipline such as suspension, revocation, or further fines based on the violations cited in this Order; and be it further,

**ORDERED** that this is a formal order of the Maryland Board of Physical Therapy Examiners and as such is a public document pursuant to Maryland Code Ann., Gen. Provisions § 4-333(b).
