# PRE-CHARGE CONSENT ORDER

#### Background

On May 31, 2011, the license to practice physical therapy held by the Respondent, Jennifer Chu, P.T. (the "Respondent") expired. On March 13, 2013, the Respondent contacted the Maryland Board of Physical Therapy Examiners (the "Board") during which she notified the Board that she inadvertently failed to renew her license and had been practicing in Maryland without a license since June 1, 2011.

In lieu of issuing formal Charges against the Respondent for violations of the Maryland Physical Therapy Act, Md. Code Ann., Health Occ. § 13-101 *et seq.*, the Board voted to resolve this matter by way of a Pre-Charge Consent Order. As a result, the Board and the Respondent have agreed to resolve this matter as set forth in this Consent Order.

#### FINDINGS OF FACT

- 1. The Respondent was originally licensed in Maryland on October 23, 1997.
- 2. On May 31, 2011, the Respondent's license to practice physical therapy in Maryland expired.
- Due to the Respondent's relocation of her business office, and other personal issues, the Respondent inadvertently failed to renew her license.
- 4. In addition, the Respondent failed to notify the Board of her change of mailing address.
- 5. On March 13, 2013, the Respondent contacted the Board to report the lapse of her license

and was advised to immediately cease practicing.

6. The Respondent filed a written statement of explanation detailing various personal issues that contributed to her failure to timely renew her license. In addition, the Respondent indicated that she only practiced in Maryland on a limited basis (once a week) during the period of lapse.

### **CONCLUSIONS OF LAW**

Based on the foregoing Findings of Fact, the Board concludes that the Respondent is in violation of the Maryland Physical Therapy Act, Health Occ. §§13-316(15) and 13-401.

## **ORDER**

Based on an affirmative vote of the Board, it is this <u>Brd</u> day of <u>April</u>, 2013, hereby:

**ORDERED** that the Respondent pay a fine of \$5,000, payable to the Maryland Board of Physical Therapy Examiners within six (6) months of the date of this Order; and be it further,

**ORDERED** that the Respondent submit a reinstatement application and comply with all applicable fee and continuing education requirements; and be it further,

**ORDERED** that this is a formal order of the Maryland Board of Physical Therapy Examiners and as such is a public document pursuant to the Maryland Annotated Code, State Government Article, Section 10-617(h).
