SUPPLEMENTAL CONSENT ORDER

On November 5, 2018, the Maryland Board of Physical Therapy Examiners (the “Board”) entered into a Consent Order with Cameron K.S. Jones, P.T., License No. 22379, based on violations of the Maryland Physical Therapy Act. Pursuant to the Consent Order, Mr. Jones’ license to practice physical therapy was placed on probation for two years, during which he was required to pay a fine of \$3,000, complete two Board-approved courses, meet on a monthly basis with a Board-approved supervisor, and, within the first six months of probation, successfully pass the Board’s closed-book law examination with a passing score of 90 percent. Despite the Board allowing Mr. Jones three opportunities to take the law examination in the relevant time period, Mr. Jones did not successfully pass the exam within the first six months of probation as required by the terms of his probation. As a result, the Board determined that Mr. Jones is in violation of the terms of probation included in his November 5, 2018 Consent Order with the Board. The Board, however, determined that further disciplinary action is not necessary at this time, provided that Mr. Jones agree to the terms of this Supplemental Consent Order.

ORDER

It is this 3 day of JUNE, 2019, by an affirmative vote of the Maryland Board of Physical Therapy Examiners, hereby:

ORDERED that Mr. Jones’ November 5, 2018 Consent Order with the Board remain in

full force and effect; and be it further,

ORDERED that in lieu of successfully passing the Board's closed-book law examination with a passing score of 90 percent, and as a term of probation, Mr. Jones shall sign up for and successfully complete the next available Professional/Problem-Based Ethics (ProBE) Ethics & Boundaries Course; and be it further,


ORDERED Mr. Jones shall complete the ProBE course before he may petition to terminate probation in accordance with the Consent Order dated November 5, 2018; and be it further,

ORDERED that Mr. Jones shall bear the expenses associated with this Order; and be it further,

ORDERED that this is a formal order of the Maryland Board of Physical Therapy Examiners and as such is a public document pursuant to Md. Code Ann., General Provisions § 4-333(b).


CONSENT
