**APPROVAL OF MINUTES**

**Jamie Wilson, Secretary/Treasurer**

A motion was made to approve the Minutes of the March 8, 2024 Board meeting Minutes. It was seconded and unanimously approved.

**BOARD CHAIR REPORT**

**Susan Coppage, Chair**

- Susan Coppage welcomed members of the public, staff, and Board members. She welcomed back Tonya Hill back from maternity leave.
- Did not have updates - giving time to Lillian Reese for legislative updates

## **Executive Director REPORT**

**Karen Richards, Executive Director**

- Greetings from Tonya Hill who returned from maternity leave - congratulations!
- Update of Building - painting and new carpet
  - Empty file cabinets and storage room
  - No additional staff provided to help with emptying files
  - Last 4 weeks, staff are doing other duties as assigned in addition to their regular work
  - Purging following archive guidelines and making plans to move, scan and archive materials once facility updates are complete
  - Work being done during evenings and weekends - staff unable to access building during this time
  - Original start date was April 8 - pushed back to April 22 to allow Boards more time to clear out file cabinets and storage room
- Staff Updates
  - New part-time SW in licensing - Jean James, LCSW-C
  - Two additional part-time contractual staff for licensing have been hired - one Licensing Coordinator and one Social Worker
  - Health Investigator for Compliance Unit starting April 17th
  - Licensing Coordinator vacancy closed - waiting on candidate list to start interviews
  - Social Worker II position in Licensing posted - please refer anyone who might be interested
  - Interviews starting next week for Administrative Aide position
- Policy Workgroup on Social Work Licensure
  - Attended meetings on February 27th and March 26th
    - Straw poll vote to remove exam as requirement for Bachelor's and Master's level licensing held at both meetings - vote on March 26 was 15 in favor - 4 opposed - 1 abstained
  - Workgroup is required per SB871 of 2023
  - I am participating in Policy Sub-Committee - meeting next on April 19th
  - Workgroup has an Interim Report due on May 31st
  - Next meetings will feature Director of NASW Illinois and representatives from NASW Virginia and the Virginia Board of Social Workers
    - Virginia has not eliminated exam in their regulations - also have two alternative paths
  - The Policy Workgroup meetings are open to the public - next meeting is April 30th - see below to the link for the link to group web page which has links to meetings

## LEGISLATIVE REPORT

Lillian Reese, Legislative & Regulations  
Coordinator

- Last update for 2024 - session
- Time to start considering Legislation for 2025 - concept papers due at end of May
- *HB 34/SB 204 Compact Bill* - did not pass - likely due to the exam piece - will likely be taken up again in the next session
- *HB 146/SB 221 Health Occupations Boards – Reciprocal Licensure and Certification* effective July 1 - authorized to adopt regulations to offer reciprocity with other states - can achieve the same thing as the Compact Bill and have more workers certified to practice in Maryland
- *HB 581/SB 472 State Government - Permits, Licenses, and Certificates - Processing (Transparent Government Act of 2024)* - Governor's bill - Rhonda Edwards assisted with drafting legislation which will provide a catalog of information for documents needed for permits/licenses issued by Departments - October 1 2024 -
- *HB 755/SB 106 - State Board of Social Work Examiners - Board Membership and Certified Social Worker Licenses* - clean up bill for LCSW language in regulation as Board no longer issuing this level
- *HB 1120/SB 794 - Approval of Authorized Sponsors* - bill withdrawn due to agreement with NASW-MD and BSWE - will update regulations using suggested language from the bill - CE and Stat & Reg committee will work on updates
- *HB 1285/SB 931 - Workers' Compensation – Rehabilitation Practitioners – Licensed Social Workers* - did not pass House and Senate
- *HB 1289 - State Board of Social Work Examiners - Practice Social Work - Definition and Scope of Authority* - did not pass out of House
- *SB 242 -State Board of Social Work Examiners - Sunset Extension* - passed and 5-year extension was granted over original 3-year
- Susan asked a question about the Reciprocity Bill - how to manage agreements and regulation with identified states? Would we identify other states first?
  - Rhonda clarified - best for Board to identify states - formulate agreement and develop regulations around reciprocity - assure that states have a “meeting of the minds” as to what they will accept from one another - there is not always a 1:1 with other states - before entering in to agreement - want to assure that the Board is willing to accept that state's licensing levels
- Susan asked question about the “clean up” bill - Lillian clarified that not all references to LCSW will be removed - there are still some places where it will remain - will discuss in committee and submit proposal
- Adrienne, Karen, and Susan thanked Lillian for all of her hard work and help during the legislative session - she is the liaison for several Boards and she is always available to answer our questions

- Committee met on April 11th - reviewed end of session and celebrated Sunset bill

- Discussed clean up bill HB 755 and HB 1120

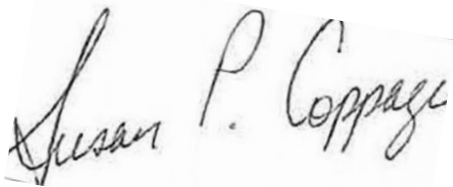
- SW Consensus - Workforce study by coalition - if survey is completed, ASWB will issue 2 CEUS

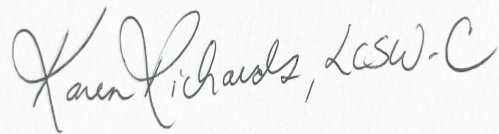
