ORDER OF PROBATION

WHEREAS, on April 1, 2022, the Maryland State Board of Social Work Examiners (“the Board”) entered into a Consent Order with **KEVIN DANIEL, LMSW, LICENSE NO. 24657** (“the Respondent”), which Reprimanded the Respondent’s License to Practice Social Work in the State of Maryland;

WHEREAS, the April 1, 2022 Consent Order provides that should the Respondent apply for renewal of his license to practice social work in the State of Maryland and his license is reinstated or reissued, the Respondent shall immediately be placed on Probation, subject to certain terms and conditions outlined in the April 1, 2022 Consent Order;

WHEREAS, on or about **October 17, 2023** the Respondent applied for the renewal of his license;

WHEREAS, on or about **November 17, 2023**, a quorum of the Board considered Respondent’s Request for Renewal of Social Work License;

WHEREFORE, it is this **17th** day of **October, 2023**, by the Board of Social Work Examiners, hereby

ORDERED, that the Respondent

ORDERED, that Respondent's License be placed on immediate **PROBATION for a minimum of ONE (1) years**, effective from October 18, 2023 and Probation; and it is further

ORDERED, that the Respondent shall comply with the specific terms and conditions of probation as set forth in the April 1, 2022 Consent Order, which is incorporated herein by reference; and it is further

ORDERED that at the conclusion of the **ONE (1) PROBATIONARY PERIOD**, the Respondent may submit a written petition the Board for a termination of his probation. The Board may terminate the Respondent's probation depending on whether Respondent has fulfilled all of the terms and conditions of this Order of Reinstatement and Probation and whether there are any pending complaints against the Respondent; and it is further

ORDERED, that if the Respondent violates any of the terms and conditions of this Final Order, the Board, in its discretion, after notice and an opportunity for an evidentiary hearing if there is a genuine dispute as to the underlying facts, or an opportunity for a show cause hearing before the Board otherwise, may impose any sanction that the Board may have imposed in this case, including additional probationary terms and conditions, a reprimand, suspension, revocation, and/or monetary penalty; and it is further

ORDERED, that the Respondent shall be responsible for all costs incurred in fulfilling the terms and conditions of this Final Order; and it is further

ORDERED that the Respondent shall not serve or continue to serve as: A Board-Authorized Sponsor, presenter and/or trainer of social work continuing education


learning activities, a Board-Approved Supervisor, an Ethics Tutor, or conduct evaluations ordered by the Board for a period of **FIVE (5) YEARS** from the date of this Final Order; and it is further

ORDERED, that this order be **NUNC PRO TUNC** to the effective date of **October 18, 2023**; and it is further

ORDERED, that for the purposes of public disclosure, this Order Lifting Suspension and Reinstating License with Probationary Terms is considered a **PUBLIC DOCUMENT** pursuant to Md Code Ann., Gen. Prov., Art. §§ 4-101 et seq. (2019 Rep. Vol.) and Health Occupations Article § 1-607 (2019 Rep. Vol.).
