**ORDER FOR TERMINATION OF PROBATION**

**WHEREAS**, on August 2, 2022 the Maryland State Board of Social Work Examiners (“the Board”) entered into a Consent Order with Harry T. Goldwater, LCSW-C, License No. 18348 (“the Respondent”) which Reprimanded Respondent’s license to practice social work in the State of Maryland and placed Respondent’s license under Probation for minimum of **ONE (1) YEAR**, until the Respondent successfully completed the terms and conditions of Probation as set forth in the July 20, 2022 Consent Order which is incorporated herein by reference;

**WHEREAS**, the Respondent, upon satisfaction of the terms and conditions of Probation set forth in the August 2, 2022 Consent Order submitted to the Board a petition to terminate the terms and conditions of Probation concerning his license to practice clinical social work; and

**WHEREAS**, on or about February 9, 2024 a quorum of the Board considered the Respondent’s petition to terminate the terms and conditions of probation concerning the license;

**WHEREAS**, the Board approved Respondent’s petition to terminate the Probation, and effective upon the date of signature by this Board it is hereby:


**ORDERED**, that the Respondent’s petition to terminate the terms and conditions of Probation is hereby **GRANTED**; and it is further

**ORDERED**, that Respondent shall not serve or continue to serve as: a Board-Authorized Sponsor, presenter and/or trainer of social work continuing education learning activities, a Board

Approved Supervisor, an Ethics Tutor, or conduct evaluations ordered by the Board for a period of 5 years from the date of the August 2, 2022 Consent Order; and it is further

**ORDERED**, that this is a Final Order of the Maryland State Board of Social Work Examiners, and is a **PUBLIC DOCUMENT** which shall be posted to the Board's website pursuant to Md. Code Ann., Gen. Prov., Art. § 4-101 et. seq. (2019 Rep. Vol.) and Health Occupations Article § 1-607 (2019 Rep. Vol.)
