**ORDER LIFTING SUSPENSION AND REINSTATING LICENSE WITH
PROBATIONARY TERMS**

WHEREAS, on March 10, 2006, the Maryland State Board of Social Work Examiners (“the Board”) entered into a Consent Order with Mairi Brighid Grizzard, LGSW, License No. G10317 (“the Respondent”), which Suspended the Respondent’s license to practice social work in the State of Maryland for a period of two (2) years;

WHEREAS, on February 26, 2023, the Respondent formally petitioned the Board to lift the terms and conditions of her licensure and submitted documentation of her completion of the suspension requirements of the March 10, 2006 Consent Order;

WHEREAS, the March 10, 2006 Consent Order states that “prior to being placed on probation, the Respondent shall show evidence of meeting the requirements for renewal, or if the license has expired, for reinstatement”;

WHEREAS, on May 12, 2023, a quorum of the Board considered the Respondent’s petition to terminate the Suspension of her license;


WHEREAS, the Board approved Respondent’s petition to terminate the Probation, and effective upon the date of signature by this Board it is hereby:

ORDERED, that the Respondent has met all the conditions and requirements of the March 10, 2006, Consent Order’s terms of Suspension; and it is further

ORDERED, that Respondent is free to apply for **REINSTATEMENT** of her license to practice, in compliance with the Maryland Social Work Act, codified at Md. Code Ann., Health Occ. §§ 19-101 *et seq.* (2014 Repl. Vol. and 2020 Supp.) and other applicable laws and regulations;

ORDERED, that should Respondent apply for Reinstatement, and should Respondent's application for Reinstatement be granted, Respondent's license shall be subject to the Probationary Terms listed in the March 10, 2006, Order (incorporated herein for reference) for a minimum of **two (2) years**;

ORDERED, that this is a Final Order of the Maryland State Board of Social Work Examiners and is a **PUBLIC DOCUMENT** which shall be posted to the Board's website pursuant to Md. Code Ann., Gen. Prov., Art. § 4-101 *et. seq.* (2019 Rep. Vol.) and Health Occupations Article § 1-607 (2019 Rep. Vol.)
