



MARYLAND BOARD OF SOCIAL WORK EXAMINERS
CONTRACT FOR SUPERVISION

This contract is made by and between (print supervisee name) _____
 (hereinafter referred to as the Supervisee) and (print supervisor name) _____
 (hereinafter referred to as the Board Approved Supervisor or 'BAS'); **and acknowledged by the Agency Administrator, if the BAS is an Independent (not an employee of the agency/practice) Supervisor.**

The BAS agrees to provide supervision in compliance with the regulations outlined in the Annotated Code of Maryland (COMAR 10.42.08 - Supervision). The parties mutually agree to the following:

1. FREQUENCY AND DURATION

- For the **Licensed Certified Social Worker-Clinical (LCSW-C)**, the supervision requirement is a minimum of 100 hours and supervision must be maintained until the LCSW-C is issued.
- For **Independent Practice** status, the supervision requirement is a minimum of 150 hours and must be maintained until the Independent Practice status is granted.
- Supervision sessions shall be a minimum of 3 hours of face-to-face supervision per month or 1 hour of face-to-face supervision for every 40 hours worked.
- Group supervision shall include no more than 6 supervisees and only half of the required hours (50 hours) may be obtained from group supervision.

2. SUPERVISION

A. The supervisor shall:

- 1) For the LCSW-C, qualify as a Board approved LCSW-C in Maryland and maintain this designation for the duration of the supervision.
- 2) For Independent Practice status, qualify as a Board approved Licensed Master (LMSW) or Bachelor Social Worker (LBSW).
- 3) Provide or ensure that the supervisee receives the required minimum hours of supervision.
- 4) Conduct supervision according to the standards outlined in Maryland Health Occ. Code Ann. ("H.O.") §19-302 of the Social Work Practice Act (H.O. §§ 19-101 et seq.) and Regulations governing the Practice of Social Work COMAR 10.42.01 through 10.42.08.
- 5) Maintain documentation of supervisory sessions for at least 5 years, including dates, duration, and focus of supervisory sessions.
- 6) Provide a written evaluation of the supervisee's progress to the supervisee every 6 months.

B. The supervisee shall:

- 1) For the LCSW-C, be licensed in the State of Maryland as a LMSW and maintain that designation for the duration of supervision.
- 2) For Independent Practice status, be licensed in the State of Maryland as a LBSW or LMSW and maintain that designation for the duration of supervision.
- 3) Receive the minimum hours of supervision from a BAS as long as they are practicing social work in Maryland.

- 4) Become knowledgeable about Maryland Health Occ. Code Ann. (“H.O.”) §19-302 of the Social Work Practice Act (H.O. §§ 19-101 et seq.) and Regulations governing the Practice of Social Work COMAR 10.42.01 to 10.42.08.
- 5) If supervision with the BAS ends, obtain supervision from another BAS, **under a written contract**, on or before the end of that supervisory relationship.

3. DURATION AND TERMINATION

- This contract is effective as of the date all parties sign; will remain in effect until either party ends the supervisory relationship; and may be terminated immediately if the BAS does not maintain their Board approved status.
- All signatories to this contract should sign within 5 business days of each other.
- Digital signatures are allowed, provided that the certificate of authority or timestamp audit is provided with the signed contract.

4. AGENCY ACKNOWLEDGMENT (only required for Independent [not an employee of the agency/practice] Supervisors)

- Social work supervision is accountable to the supervisee’s employer.
- The Agency Administrator must be aware if the BAS is an independent supervisor engaged by the supervisee.
- The Agency Administrator must sign the contract on or before the date supervision begins.
- The Agency Administrator should verify that the supervisor is a Board Approved Supervisor.
- The Agency Administrator should verify that the supervisee is licensed by the Board to practice social work in Maryland.
