If your program has not done so already, please ensure that all individuals who are responsible for the day-to-day management and operation of a residential child care program submit their application to the Board. Applications may be downloaded from the Board's web site.

Our joint efforts will ensure that children in Maryland's residential child care programs are provided quality care.

WHAT IS BRCCPA?

Chapter 438 of the Acts of the 2004 General Assembly, as a result of recommendations from the 2001 Governor's Task Force to Study Licensing and Monitoring of Community-Based Homes for Children, established the Board for the Certification of Residential Child Care Program Administrators (BRCCPA) to establish standards for certification and disciplining of residential child care program administrators.

The Board was appointed in October, 2005 and consists of 11 members. There are 6 representatives that are from various State agencies involved in the licensing and monitoring of residential child care programs and 5 are Governor appointees, 3 of which are program administrators and 2 are consumer members.

MEET THE MEMBERS OF THE BOARD

Dr. Albert Zachik, Board Chairman

Albert Zachik, M.D., is the Director of the Office of Child and Adolescent Services with the Mental Hygiene Administration in the Maryland State Department of Health and Mental Hygiene.

Dr. Zachik is a child and adolescent psychiatrist and a member of the American Academy of Child and Adolescent Psychiatry's Workgroup on Community Systems of Care.

Dr. Zachik is a member of the clinical faculty in psychiatry at the Johns Hopkins University School of Medicine and the Georgetown University School of Medicine.

Dr. Zachik has a special interest in developing a full system of care in

Maryland for children and adolescents with mental health need which integrates mental health services into all existing programs for youth including schools, and early childhood, juvenile services, and social services programs.

Robin El Amin, Board Vice Chair

Robin El Amin has been a family advocate for over 15 years serving families who have children with learning disabilities or in the juvenile justice system.

She has gained valuable experience from her children; three of which have disabilities. She currently works as a family navigator for Baltimore's Families

Carmen Amyot Brown, LCSW-C, is the Executive Director of the Office of Licensing and Monitoring (OLM) at the Department of Human Resources (DHR).

Ms. Brown is a clinical social worker with over 20 years of child welfare experience and has worked in Maryland licensed child placement agencies and/or residential child care programs for over 12 years.

In her role as Executive Director of the OLM at DHR, she is responsible for the oversight of DHR's licensing and monitoring functions as they pertain to over 300 licensed private providers and over 100 non-DHR licensed providers. She has purview over regulatory review in relation to residential child care and child placement agency regulations and is involved in all legislation effecting the same.

Did you know?

Certified Residential Child Care Program Administrators are required to notify the Board within 30 days of a change of: (1) name, (2) home address, (3) name or address of the administrator's employer; or (4) business connection of the administrator.

Failure to provide the Board with up-to-date information may constitute grounds for action under Health Occupations Article, §20-313, Annotated Code of Maryland.

A change of address form should be completed and returned to the Board. The form may be downloaded from the Board's web site.

MEET THE MEMBERS OF THE BOARD

Steve Sorin, Maryland State Department of Education

Steve Sorin is the Branch Chief for the Special Services Branch in the Division of Special Education and Early Intervention Services at the Maryland State Department of Education. Mr. Sorin is responsible for the management of the Interagency Rate Committee, which is charged with establishing rates for residential services for children provided by programs licensed by the DHR, DJS and DHMH.

Mr. Sorin is also the manager for the Health Related Services Section, which has responsibility for the implementation of the waiver for the Medicaid Home and Community Based Services for Children with Autism Spectrum Disorder. In addition, that Section is responsible for the provision of technical direction and monitoring of Medicaid school based services by local school systems, local lead agencies, special education nonpublic schools, Maryland School for the Blind, and Maryland School for the Deaf.

Shelley Tinney, Governors Office of Children

Shelley Tinney is the Director of Community Resource Development at the Governor's Office for Children.

Thank you to everyone for making my transition so enjoyable. I would like to especially thank Laurie Sheffield-James, who took upon the additional responsibility of staffing the Board while managing the State Board of Morticians. Her leadership and efforts in organizing the Board were tremendous.

The Board has received over 150 applications and I have noticed in reviewing applications that certain required information is sometimes not included with applications, such as:

- Original, official transcripts to document educational requirements;
- Results of a state and national criminal history records check ; and/or
- 3 professional references in sealed envelopes, signed by the writer

over the flap. One of which must be from a supervisor.

Failure to submit all required information results in the certification process taking longer than it needs to.

If you have not done so already, please submit your completed application to the Board as soon as possible.

EFFECTIVE APRIL 1ST ...

Please be advised that effective April 1, 2008, the Board will begin to enforce the certification requirement. The Board will supply new applicants with fingerprint cards that will be preprinted with certain specified information to obtain criminal background checks.

Correspondence regarding the certification requirement was sent on multiple occasions to agencies identified by their licensing authorities throughout 2007. The Board extended a 180-day grace period to all individuals to receive their initial certification. Therefore, effective April 1, 2008, the Board will begin to enforce the certification requirement.

The Board has been advised by the Criminal Justice Information System that it can no longer accept copies and individually or agency submitted state and national criminal history record reports for certification purposes. Therefore, effective April 1, 2008, the Board will supply all <u>future</u> applicants with fingerprint cards that will be preprinted with certain specified information. The results of the checks will be sent to both you and the Board simultaneously. Candidates are responsible for paying any fees for the background check directly to CJIS. A fact sheet on this new process is posted on the Board's web site.

FREQUENTLY ASKED QUESTIONS.

How do I know if I need to be certified? Any individual who is responsible for the day-to-day management and operation of a residential child care program must be certified by the Board.

Are residential child care programs required to have certified program administrators? YES. Maryland Code Ann, Health Occupations Article, Title 20, requires that an individual receive certification from the Board before the individual may be a residential child care program administrator in the State.

How many certified residential child care program administrators should a residential child care program have? Residential child care programs have different needs and organizational structures. It is incumbent upon each residential child care program, based upon the needs of the organization and its structure, to determine who on their staff is responsible for the day-to-day management and operation of the program.

What do I need to do to become certified? An individual who wishes to become certified should submit the following to the Board:

- A completed, certified application with fee enclosed;
- Three professional references from individuals who can attest to your work experience and competence as a child care
 administrator. One reference must be from a supervisor;
- Evidence of supervisory or administrative experience in a human service field;
- A state and national criminal background check executed on forms provided by the Board through the Criminal Justice Information System;
- Original, official transcripts to document either a Master's or Doctoral degree or bachelor's degree; and,
- Pass a Standards Examination administered by the Board.

How do I submit professional references to the Board? Individuals who wish to become certified by the Board are required to submit 3 professional references from individuals who can attest to your work experience and competence as a child care administrator. At least 1 reference must be provided by present or former supervisor. Forms are included in the certification packet for use by your references. All references must be signed by the writer on the back of the envelope, over the envelope flap. References may be verified by the Board.

What type of supervisory or administrative experience is required for certification? Individuals with a Bachelor's degree from an accredited college or university must have at least 4 years experience in the human service field with at least 3 years in a supervisory or administrative capacity. Individuals with a Master's degree from an accredited college or university must have at least 2 years experience in the human service field with at least 1 year experience in a supervisory or administrative capacity.

Supervisory or administrative experience must be completed within the last 10 years and meet the requirements of COMAR 14.31.06.03B(6). Supervisory or administrative experience is considered the shared responsibility for managing the operation of a program and supervising at least one member of staff. Supervision is defined as having the following responsibilities: hiring, assigning duties, disciplining and rewarding staff, approving leave requests, and formally evaluating staff.

NOTE: Experience in the following areas does not count towards the supervisory or administrative experience requirements: (1) child-placing agency; (2) child-placing institution; (3) foster parent; or (4) caregiver in a foster home.

Can I get a waiver for the experience requirements? No. The board does not have the authority to grant waivers for required experience.

Can criminal background checks be completed by private agencies? No. Individuals must submit to the Board the results of a state and national criminal history records check completed by the Criminal Justice Information System within the last 24 months.

When and where is the Standards Examination given? Once the Board has approved your application, you will be invited to take the Standards Examination. Exam dates may be found on the Board's web site. Special accommodations can be made for alternate exam dates by contacting the Board.

What is a passing score on the Standards Examination? There are 95-multiple choice questions on the exam. You must receive a passing score of 75% on the exam.

What happens if I fail the Standards Examination? If you fail the exam, you may retake the exam. There is a fee of \$125 charged each time a candidate takes the exam.

EXAM DATES

The Standards Examination is administered to candidates upon invitation by the Board. The exam is administered at the Board's office, unless otherwise indicated, and the dates have been scheduled through September.

There is no study guide for exam outside of the Code of Maryland Annotated Regulations (COMAR) 14.31.05 and 14.31.06. Candidates should acquaint themselves thoroughly with these regulations as the test will be based exclusively on these regulations. The regulations may be obtained several ways:

- Regulations are available at all public libraries;
- Regulations may be downloaded from the Board's web site by clicking on the "Statutes and Regulation" link; or
- Regulations may be downloaded from the Division of State Document's web site (http:// www.dsd.state.md.us)

Please note that if you choose to download regulations from the Division of State Documents web site, you will need to download each subsection of each regulation.

Please note that there is a fee of \$125 each time a candidate retakes the examination.



MANY CHILDREN LEFT BEHIND: HEALTH DISPARITIES IN U.S. CHILDREN

In its landmark report of 2002, *Unequal Treatment: Confronting Racial and Ethic Disparities in Health Care*, the Institute of Medicine (IOM) illustrated unequivocally that America's ethnic and racial minority groups suffer persistent health and health care disparities. Moreover, the cadre of experts reviewing national data on health disparities for the IOM pointed out that health disparities persist regardless of insurance status, socio-economic background severity of disease and site of care, and concluded that biases and prejudice on the part of health care providers not competent to care for linguistically and culturally diverse patient populations are among the major culprits to health disparities.



Despite a growing awareness to health disparities and major initiatives nation-wide, little advancement has been made in reversing disparities in children's health. It has been well documented that major disparities in health and access to care

exist in children with or without insurance. Immunization rates are lower, t here are more pediatric emergency visits and less care by a regular source, higher exposure to environmental pollutants such as lead, higher incidence of untreated dental carries, higher rates of childhood obesity and poor nutrition, and the list goes on. Researchers have shown that pervasive racial disparities in the health of American children contribute to gaps in school readiness, and an overall poorer performance in school starting from kindergarten and even in the pre-K period. (Currie, 2005). Moreover, the rate of uninsured children in the United States has increased for the first time in seven years from 10.8% in 2004 to 11.2% in 2005. (Economic Policy Institute, 2008). There are at this time nearly ten million uninsured children ages 18 and under in the United States. Uninsured children are more likely to suffer dire consequences from preventable disease. One recent tragic example in Maryland is the death of a twelve year old child from the consequences of an infected tooth.



In addition to chronic diseases disproportionally afflicting minority children, these

children are more likely to live in poverty and suffer from an unfavorable socio-cultural environment. Residential instability, living in overcrowded dwellings, displacement from parents and other caregivers all have a very significant and long lasting impact on children contributing to both physical and mental health.

Maryland is the fifth most diverse state in the nation, with more than 41% of residents that are members of ethic and racial minority groups. In addition, Maryland is also the resettlement site for many immigrants and refugees who are

2007 ACCOMPLISHMENTS

The Board has made significant progress during 2007 in fulfilling its mission and met key milestones.

HIGHLIGHTS OF ACHIEVEMENTS:

- Finalized draft regulations establishing quality standards for child care program administrators;
- Developed, in collaboration with Towson State University, the standards examination;
- Initiated the certification process by sending certification applications to over 200 residential child care program providers licensed by DHR, DJS and DHMH;
- Administered standards examination;
- Hired an executive director; and,
- Secured permanent office space.

GOALS FOR 2008:

- Complete initial certification cycle;
- Review and evaluate standards examination;
- Develop a continuing education approval and auditing process in anticipation of renewal cycle;
- Develop a complaint form;
- Investigate on-line renewals;
- Issue a Spring and Fall Newsletter; and,
- Identify, in collaboration with licensing agencies, topics for educational alerts for certified residential child care program administrators.

LEGISLATIVE AND REGULATORY ROUND-UP

House Bill 392 — "Juvenile Services—Mental Health and Substance Abuse Screenings for Detained Youth." This bill would have allowed a child detained by the Department of Juvenile Services to consent to mental health and substance abuse screenings without parental consent. House Bill 392 received an **unfavorable** report from the House Judiciary Committee.

House Bill 248 and Senate Bill 240 — "Residential Child Care Programs—Behavior Management Interventions." This bill was withdrawn by the sponsors as the restraint and seclusion regulations have already been drafted. The regulations (revisions to COMAR 14.31.06) were published in the Maryland Register on February 1, 2008.

Senate Bill 742 — "Human Services - Residential Child Care Program - Bill of Rights". Effective October 1, 2008, a residential child care provider, including those licensed by the Developmental Disabilities Administration, are required to conspicuously post a Residents' Bill of Rights in the facility. The bill of rights establishes a resident's right to be treated fairly and receive appropriate educational and guidance services in an environment that is free of discrimination or abuse. The resident and his or her family have a right to communicate with each other, as appropriate, and express their opinions about services provided. Residential child care providers are also required to develop and distribute a handbook that includes specified information about the provider's policies and procedures. The provider must document receipt of the handbook by each child receiving care and his or her parents or guardians.

Senate Bill 782 — "Residential Child Care Programs - Statement of Need." Effective October 1, 2008, the Departments of Human Resources and Juvenile Services are required to issue a county-specific statement of need before a residential child care program is issued a license, an existing program is relocated, an existing site is expanded, or the number of placements in an existing program is increased. A licensing agency must consider the special needs of the affected children and consult with relevant stakeholders when developing a statement of need. DHR and DJS must publish notice of the statement of need in the Maryland Register. DHR, DJS, and the Governor's Office for Children must report by October 1, 2008 on development and coordination of processes for issuing statements of need and means to expand capacity in underserved areas.

Senate Bill 783 - "Residential Child Care Programs—Certification of Residential Child Care Program Professionals." Effective October 1, 2008, the Board's name will change to the State Board for the Certification of Residential Child Care Professionals. All child and youth care practitioners in residential child care programs, with the exception of those in programs licensed by the Developmental Disabilities Administration, must become certified by October 1, 2013.

COMAR 10.57 (the Board's regulations) - The emergency regulations became effective on January 7, 2008, and the notice of final action became effective on April 7, 2008. You may download the regulations from the Board's web site. The Board will provide periodic updates as we begin to implement this new requirement.
