- Developing a certification program for RCYCPs;
- Promulgating regulations to implement the certification program for RCYCPs; and
- Refining our continuing education approval and audit processes.

There is still room for improvement. Staff over the next fiscal year will identify ways to improve the services provided by the State Board.

In addition, State Board will begin to develop uniform sanctioning guidelines and other measures to improve our complaint and investigation processes.

As the State Board's first renewal cycle comes to a close, there are many lessons learned. Over the next several months, staff will embark on and a review process to identify ways to also improve this process.

The State Board's goal for FY 2012—growth and improvement. While the number of certified individuals is anticipated to grow, due to the implementation of the RCYCP certification

program, the State Board needs to ensure that administrative processes are in place to adequately hand the influx of anticipated applications.

Mission & Vision

State Board's Mission...The mission of the State Board is to protect children living in Maryland's residential child care programs through certifying and regulating residential child care professionals; receiving and resolving complaints; and setting standards for the practice of residential child care.

State Board's Vision...The State of Maryland will provide qualified residential child care professionals to further the well-being of children living in Maryland's residential child care programs.

Acting Capacity — State Board Approval is Required

Are you aware that State Board approval is required for <u>ALL ACTING</u> CAPACITY APPOINTMENTS?

Health-Occupations Article, Title 10, §20-301 and COMAR 10.57.02.02 provide that in the event a certified residential child care program administrator (CRCCPA) is not available, the residential child care program's Board of Directors may appoint a noncertified individual to serve in the capacity of acting program administrator for a period not exceeding 180 days provided the individual meets the minimum qualifications as outlined in COMAR 10.75.02 for a program administrator and is approved by the State Board.

In order to obtain approval from the State Board for an acting capacity appointment, the residential child care program must submit to the State Board:

- (1) An application (the form is available on the State Board's web site;
- (2) The application fee of \$75;
- (3) Written justification clarifying the reasons why acting capacity is necessary; and,
- (4) A copy of the individual who is appointed resume or CV, college diploma noting highest degree earned, and criminal history record check.

All applications must be submitted by a member of the residential child care programs Board of Directors and be signed by the program President.

Individuals who are approved by the State Board for acting capacity will be issued an approval number that is valid for 180-days.

The Board now provides online verification of acting capacity approvals. Verification is available on the State Board's website by clicking on "Online Verifications".

Continuing Education

Continuing education is mean to foster improvement, advancement and extension of the CRCCPAs professional skill and knowledge relating to residential child care programs. It is, therefore, intended to be training obtained above the minimum annual training requirements in COMAR 14.31.06 F.

CRCCPAs must complete 40 continuing education units (CEUs) per renewal cycle.

Continuing education may include academic course work, workshops, seminars, etc. The State Board will accept a MAXIMUM of 5 CEUs per renewal cycle in the content area of behavioral management. Continuing education MAY NOT include CPR or First Aid.

Effective September 1, 2010, the Board WILL NOT process renewal applications of CRCCPAs who have not obtained the required 40 CEUs for renewal.

Limits on Behavioral Management CEUs

The Board will accept a MAXIMUM of 5 CEUs per renewal cycle in the content area of behavioral management. The types of training programs included in the behavioral management content area are the State-approved behavioral intervention trainings listed on the Governor's Office for Children's web site, and include:

- Behavioral Principles and Strategies
- Therapeutic Crisis Intervention
- MANDT
- Managing Aggressive Behavior
- TACT2
- Safe Crisis Management

Renewal Process

At least 3-months prior to the expiration of your certification, the State Board will send you a renewal notice by first class mail to your address of record. The renewal notice will state the date your certification expires, the date by which your renewal application must be received by the State Board for a renewal certificate to be issued, and the amount of your renewal fee.


In order to qualify for renewal, CRCCPAs must:

- (1) Complete the renewal application;
- (2) Your renewal letter will be marked if you need to: (a) submit

- to a state and national criminal history record check via LiveScan, or (b) provide a passport size photo;
- (3) Complete a Release to Process Renewal Application;
- (4) Certify a minimum of 40 CEUs within the 2-year period prior to your renewal date indicated on the Affidavit of Attendance at State Board Approved Continuing Education Programs; and
- (5) Provide copies of certificates of completion for all continuing education programs noted on the Affidavit

The renewal fee is \$200. Failure to renew your certificate within 1-month of your expiration date will result in a \$100 late fee. Failure to renew within 3-months of your expiration will result in a \$200 reinstatement fee, \$100 late fee, and \$200 renewal fee. Failure to provide all required documents will result in a \$5 reprocessing fee.
