- D. Legislation On May 2, 2012, the Governor signed into law:
  - 1. SB 868 (Ch.312)/ HB (Ch.813) Residential Child Care& Youth Care Practioners-Certification- Modification
  - 2. HB 72 (Ch.350) State Board for the Certification of Residential Child Care Program Professionals- Sunset Extension & Program Evaluation

- E. Regulation- Sanctioning Guidelines- Secretary adopted on May 10, 2012: The Secretary, Maryland Department of Health and Mental Hygiene adopted new Regulations .01.05 under new Chapter, COMAR 10.57.10 Disciplinary Sanctions and Monetary Penalties. This action, proposed for adoption in 39:6 Maryland Register 441-446 on March 23, 2012 has been adopted as proposed.
