DISABILITY EMPLOYMENT AWARENESS MONTH  
OCTOBER 2021

- WHEREAS, Disability Employment Awareness Month is an opportunity to recognize the contributions of workers with disabilities and through national and local campaigns, create greater awareness of the needs and skills individuals with disabilities bring to employers; and
- WHEREAS, We believe in a Maryland which recognizes the untapped potential for all our citizens, including those with disabilities, to live, work, and thrive in our communities; and
- WHEREAS, As Maryland we are dedicated to the principles of the Americans with Disabilities Act, particularly as it relates to the rights and freedom for people with disabilities to work and advance in their chosen careers and lead independent and full lives in their communities; and
- WHEREAS, We recognize the contributions of essential employees with disabilities who continue to serve our communities during the pandemic; and
- WHEREAS, We are committed to the principle that business profits by investing in workers with disabilities; Maryland will continue to take an equal employment opportunity for Marylanders with disabilities and consider award the job opportunities for working age adults with disabilities thereby giving more Marylanders a chance to contribute to the state's economic life and enjoy the rewards of their contributions; and
- WHEREAS, We are committed to the principle of providing equal opportunities, access, and choice for Marylanders with disabilities. We are committed to the principle of a Maryland in which all people with disabilities have the knowledge and influence to make a difference in their lives and the lives of others.

NOW, THEREFORE, I, LARRY HOGAN, GOVERNOR OF THE STATE OF MARYLAND, do hereby proclaim OCTOBER 2021 as DISABILITY EMPLOYMENT AWARENESS MONTH in Maryland, and do command the observance of all our citizens and encourage them to participate and promote across Maryland the year which celebrates the rights and abilities of those with disabilities.





# Deputy Secretary's Update-Appendix K

## Unwinding

---

- How will DDA handle approved PCP's that include App K flexibilities when the annual date is beyond 12/31/21? **(New - October 25, 2021)**
  - We recommend that CCS and providers work with the person and their team around the need to add or revise services (as permitted under the approved program) as soon as these interests or changes are known. This can be done in coordination with the CCS monitoring process or through an upcoming annual PCP. It is most important that all service additions are done before services are provided so this should be carefully timed with the Appendix K flexibilities end date

*Note: Providers need to update their Service Implementation Plan (SIP) to reflect virtual supports as one of the service delivery models and share with the CCS. The CCS will confirm with the person and upload into the Client Attachments*

# Deputy Secretary's Update-Appendix K

## Unwinding

---

- What is needed for providers to continue to offer some services virtually after 12/31/21? Does this need to be outlined in the program service plan (PSP)? **(New - October 25, 2021)**
  - Yes. As detailed in Memo #3 - DDA Amendment #3 - Virtual Supports - February 16, 2021 , allowable virtual services to be offered after the end of the Appendix K flexibility will need to be outlined in the providers program service plan (PSP) and submitted prior to the end of the App K for DDA review and approval.

*Note: Providers need to submit their PSP to the DDA before 12/31/21. The DDA will follow up with providers on any questions. Providers that submit by this due date can continue to provide virtual services, as permitted by the waiver, during the DDA review and approval process*

## Unwinding

- How will residential providers bill for participants when their day programs are still not open once App K ends?
  - Amendment #3 provides for use of dedicated supports/shared hours or add-on hours to continue to meet these needs and adjustments

# Deputy Secretary's Update-Appendix K

## Unwinding

---

- What happens longer term when a person wants virtual supports but requires residential dedicated supports as well – can they get two waiver services at same time?
  - No, meaningful day virtual service and residential dedicated supports can not be provided at the same time
  - Dedicated supports can be provided prior to and after meaningful day virtual supports

# Deputy Secretary's Update- LTSS Expansion

---

- Early piloting efforts have gone incredibly well and have been such a positive reflection of the collaborations between the providers, CCS agencies and our regional staff
- The learnings from the LTSSMaryland-DDA Module will support our planned transition from PCIS2 to LTSSMaryland-DDA Module. The DDA is working in partnership to develop additional readiness tools, including a go-live playbook, readiness self assessment, readiness checklist and other resources to assist providers as we move forward
- MDH/DDA is planning for expansion in CY22. Information on this expansion will be shared following the completion of the rate study

# Deputy Secretary's Update-American Rescue Plan Act of 2021 (ARPA)

---

- The Centers for Medicare & Medicaid Services (CMS) has launched a new landing page on Medicaid.gov for state Medicaid agencies and stakeholders to access information about states' plans to enhance, expand, and strengthen home and community-based services across the country using new Medicaid funding made available by the American Rescue Plan Act of 2021 (ARP)

# Deputy Secretary's Update-American Rescue Plan Act of 2021 (ARPA)

---

- MDH remains committed to getting ARPA approved resources to DDA providers for qualified claims. Providers began receiving payments on October 28th
- These initial resources will support our providers reopening efforts and address staffing challenges to restore individual and family access to pre-pandemic levels of services
  - 5.5% retroactive rate increases will be directed to submitted claims for HCBS services billed in PCIS2
- In addition, a portion of the ARPA savings will be dedicated to non-competitive and competitive grants (\$50M and \$10M respectively) contingent on final approval of the State's spending plan

# Deputy Secretary's Update-COVID-19 Booster Shots

- Governor Larry Hogan announced Maryland has administered 280,000 booster shots. He also stated that “we have a robust network of vaccination providers, including pharmacies, primary-care providers, mobile clinics, local health departments and community health centers, and we have both the supply and the capacity to provide a booster shot to anyone who needs one”

# Deputy Secretary's Update-COVID-19 Booster

---

- Following final CDC approval, Secretary Dennis Schrader announced on Monday the updated status of COVID-19 booster shot eligibility in the State of Maryland and the opportunity to mix and match vaccines
- State health officials are strongly recommending that people with comorbidities receive either an additional dose or booster dose of a COVID-19 vaccine immediately

- 'Mix and Match' Approved-You can choose ANY vaccine as a booster shot, no matter what you received initially







# DDA Tracking




There are 17,764 people supported in services by the DDA of which 12% (2,362) have tested positive for COVID-19.




CMRO 978 Positive; Increase of 67

# DDA Tracking




There have been 2,362 participants reported as having tested positive for COVID-19 of which there have been 114 deaths.



The 114 deaths represents approximately 5% of all (2,362) participants that tested positive.



2 Deaths


# Vaccination Tracking



- Of the **17,274** participants that the agencies reported intending to have vaccinated, **15,896 (92%)** have been vaccinated,
- **1,378 (8%)** have not received a vaccine
- **137** vaccination clinics were held by the provider agencies. There are no upcoming clinics scheduled
