Deputy Secretary's Opening Remarks


- The DDA's highest priority is the health, safety, and wellbeing of people with intellectual and developmental disabilities, their families, staff, and providers

Deputy Secretary's Opening Remarks


- FY'21 Q1 payment - DDA is processing the first quarterly payment based on the FY'20 rates



DDA's Tracking




There are 17,764 people supported in services by the DDA of which 2% (380) have tested positive for COVID-19.

 WMRO 16 Positive; Increase of 1


DDA Tracking

Transitioning Youth Communication

Transitioning Youth

- Transitioning Youth (TY) are individuals with a developmental disability who qualify for a special, reserved category on the DDA's Waiting List for initiation of DDA-funded services
- If an individual meets the criteria for TY, then they are generally eligible to apply for enrollment in a DDA Medicaid Waiver program
- Potential TY include youth transitioning out from local school systems, public agencies, and private schools, the Autism Waiver, and the foster care system

Transitioning Youth

- TY and families are encouraged to explore services delivery models and service providers prior to transitioning out
- Beginning in January, TY eligible to apply for enrollment in a DDA Medicaid Waiver program receive assistance with the waiver application process
- TY must meet the DDA Waivers specific technical, medical, and financial eligibility criteria and provide supporting documentation (*e.g.* bank statements, income, trust, etc.)

Transitioning Youth

Transitioning Youth

- A provision of the Autism Waiver Appendix K includes the ability to continue funding for services covered by its waiver program application for individuals who are 22 years of age or older during the COVID-19 state of emergency
- This means Autism Waiver participants, who would otherwise be disenrolled from the Autism Waiver on June 30th, can remain in the Autism Waiver, and continue to receive services funded by the Autism Waiver, even though they have completed or concluded their entitled educational services

Transitioning Youth

- The guidance includes processes for both Autism Waiver Service Coordinators and DDA Coordinators of Community Services to support eligible Autism Waiver TYs and their families in making an informed decision as to whether to disenroll from the Autism Waiver or to continue and transition at a later date
- We have already begun to receive decisions from TY and families and are taking action to support the continued enrollment in the Autism Waiver



- What is the individual health and safety needs of people you support and how will that factor into your agency's decisions moving forward?
- Does your agency have enough PPE to control the spread of COVID-19? If not, how will you obtain necessary PPE to safely move forward, considering the possibility of a resurgence?
- Has your agency updated its emergency safety plan to address COVID-19 and a possible resurgence?

COLLABORATION

As a person driven system, the DDA encourages agencies, individuals, their families, and CCS's come together as a team to discuss what moving forward looks like for each individual person. The DDA is also committed to collaborating with our stakeholders to ensure you have up to date safety information through our collaboration with Dr. Feder, further appendix K guidance, and supporting each other as we navigate a path forward




CONSIDERATIONS

- How will you collaborate with the DDA as you move forward?

DATA

In this public health emergency data has been the driver for most local jurisdictions. As your agency begins to look at how to reopen, it will be important to have the right data to make the right decisions. The DDA is also committed to utilizing Data and facts to drive our decisions as it relates to COVID-19 guidance and recommendations




CONSIDERATIONS

CAPACITY

As your agency begins to look at reopening, it will be important to look at capacity as it relates to health and safety considerations but also workforce, financial, technology, etc. The DDA is committed to supporting agencies build their capacity through provisions of the appendix K but also through out continued collaboration with Dr. Feder, CDC liaison with MDH




CONSIDERATIONS

- What are the fiscal implications of reopening now?
- What capacity does your agency have to reopen all programs vs. a rolling reopening?
- What capacity does your agency have to look at alternative schedules?
- What capacity does your agency have to implement more remote support?
- What is the capacity of the individuals and families you are supporting to return safely?
- What is your agencies capacity to respond to a resurgence?
- What is your agencies capacity to secure adequate PPE?
- How can we rely on community resources and supports to help meet peoples needs?

ESRO E-WORKGROUP DISCUSSION

Eastern Shore Regional Office (ESRO)

- Focused on:
 - Individual Level Considerations
 - Provider Level Considerations
 - System Level Consideration
- Using the filters of health, safety, capacity, and lessons learned about new and creative ways of help people update their goals and achieve desired outcomes
- Created a google drive to share resources for the benefit of providers to use and contribute to as we continue this journey
- Our providers are at different points in their transition plans for their agencies

Key Points

- All are making efforts to be person centered and are reaching out to families in many ways to survey their opinions, offer them supports on site where necessary and to make visits
- Many are making good use of remote access but there are big issues with rural areas having lack of connectivity as well as staff training issues
- Some providers have been able to continue to accept applications and even begin services for new individuals with appropriate testing, PPE, etc. Some individuals were able to remain in essential jobs with staff support and a person was even able to start a new job with accommodations to support a job coach
