Re: Dentists - Balloting Results - 2024 Dental Board Appointments

Dear Governor Moore:

In accordance with Senate Bill 764 and House Bill 811, Chapters 211 and 212 respectively, Acts of 2008, the Maryland State Board of Dental Examiners was charged with holding a balloting process for nominations for vacancies on the Board.

For the 2024 appointments for dentists there will be two vacant positions: Robert R. Windsor, D.D.S. has concluded his second 4-year term and is not eligible for reappointment. Edwin L Morris, D.D.S. has concluded his first four-year term, and has chosen not to run for reappointment.

There will be no dental hygienist Board member vacancies in 2024.

The ballots for the two dentist vacancies have been tallied.

Dr. Harry Benavent Number of votes for Dr. Benavent: 157 Dr. Barry Cohan Number of votes for Dr. Cohan: 132

Dr. Edwin Zaghi Number of votes for Dr. Zaghi: 108
