- a) Stacey Scriven, Executive Director- Mrs. Scriven reported on the following: dentist and dental hygienist renewal cycle will begin on May 1, 2025 and run through June 30, 2025. Please check the Board's websites for updates and announcements.
- b) Helen Lee-Virgil, D.D.S., Chief Dental Officer- Dr. Helen Lee-Virgil reported on the following: The Board will host its annual Graduate Workshop for new dentists and dental hygienists May 29, 2025 from 10:00am-12:00pm, June 25, 2025 from 12:30pm-2:30pm, and August 14, 2025 from 10:00am-12:00pm. Registration will begin on May 1, 2025. The Board will also host Safer waterlines, Safer Dentistry: Strategies for excellence on May 14, 2025 from 7:00pm-8:30pm. Participants will receive 1.5 CE credits.

#### V. COMMITTEE REPORTS:

- a) <u>Anesthesia:</u> Dr. Adam Eisner reported on the following: The committee continues to review all Class I, II, III Initial and renewal permit applications. The committee will soon begin to review all application forms.
- b) <u>Applications:</u> Dr. Oluwatoyin Fatogun reported on the following: The committee works with the licensing department to review applications as they come in.
- c) Infection Control/Biosafety: Dr. Leslie Grant reported on the following: The committee continues to meet with representatives from the Legislative committee in regards House Bill 499. As of March 28, 2025, the CDC reported 483 cases of Measles in 20 jurisdictions, 5 outbreaks, and 2 deaths. There have been 157 cases of children under 5 years old, 204 cases of children 5 years to 9 years old, and 111 cases of adults 20 years and older. 97% of the people affected are unvaccinated. As of April 1, 2025, The Maryland Department of Health has reported 89 Marylanders are hospitalized due to COVID-19; 86 adults and 3 children. 17 individuals are in Intensive care; 16 adults and 1 child. Bird Flu: 70 cattle cases identified in 41 dairy herds, health risks are low. As of March 21, 2025, there have been 168,235,538 cases in poultry. As of March 28, 2025, the CDC has reported 159 pediatric deaths due to influenza, 8 deaths last week. The CDC recommends everyone 6 months and older receive an annual flu vaccine.
