Dr. Kay O'Hara called the meeting to order at 10:00 A.M.

# **Review of Agenda and Minutes**

The July 8<sup>th</sup> Agenda was approved as drafted. Mr. Anderson motioned to accept the Agenda; Ms. Harrison seconded, and the motion was unanimously voted.

The June 10<sup>th</sup> Minutes were approved as drafted. Dr. Chaney motioned to accept the Minutes; Ms. Hucek seconded, and the motion was unanimously voted.

### Review of Administrative Staff Issues, Mr. J.J. Vallone, Executive Director

- ▶ Budget/Fiscal Update: Currently, the Board is on target with a FY 2010 end-of-year "carry-over" of approximately \$300,000. State workers will not receive step or pay increases during the new fiscal year 2011; however, the Governor has restrained lay-offs for DHMH. As in the previous fiscal year, some State employees will be required to take 3-5 furlough days, dependent on employees' salaries; all State employees will be required to take 5 salary reduction days. Also, all out-of-state travel has also been cancelled.
- Netbook Project Report: The Board will be transitioning to paperless meetings and has explored the cost of ordering Netbooks (with a 12-in. screen) for each Board Member; the cost will be approximately \$300-\$400 per unit. All meeting and hearing materials will be preloaded onto the Netbooks via a thumb drive or E-mail. The Netbooks will be stored here at the Board office.

- Nominees for Consumer Member Vacancy: The Office of Appointments has made a perspective decision about the vacant position. The Board should be receiving notification soon.
- ➤ Update on the Regulation Revisions (COMAR Title 10, Subtitle 43, et seq): Ms. Congo met with Ms. Michelle Phinney, DHMH Regulations Coordinator, and reviewed/revised the Regulations page-by-page. Ms. Congo will format the revisions and return to Ms. Phinney for processing. Hopefully, the regulatory packet will be put in the final vetted format by the new Boards and Commissions' Legislative and Regulations Coordinator, Ms. Kristen Neville, and will go out for public comment sometime in the fall.
- ➤ Federation of State Massage Therapy Boards Update (FSMTB): Ms. Congo has been in contact with Ms. Debra Persinger, FSMTB Executive Director, who would like to give a presentation before the Board, probably in the fall. FSMTB serves the regulatory community and provides benefit from the knowledge gained by combining the individual State resources into a larger organization. Ms. Congo enrolled the Board for one year in the FSMTB; the first year of membership is free; thereafter, the Board will be charged a fee based on the number of licensees.
- There will not be a Board Meeting in August due to an all-day hearing. Refer to Executive Minutes for details.
