Dr. Fedorczyk called the meeting to order at 10:02am.

**Review of Agenda and Minutes:**

The May 8, 2014 Agenda was reviewed by the Board and the following revisions were suggested: Addition of subsection d to “Review of Administrative Issues, Mr. J.J. Vallone, JD, Executive Director and Ms. Adrienne Congo, MS, Deputy Director.”

Dr. Chaney moved to approve the May 8, 2014 Agenda with those revisions; Dr. Frieman seconded and the motion was unanimously voted by the Board.

The April 10, 2014 Board Minutes were reviewed by the Board. Dr. Frieman moved to approve the April 10, 2014 Board Minutes as written; Dr. Moskowitz seconded and the motion was unanimously voted by the Board.

**e) Update on PC Transition**

Deputy Director, Ms. Adrienne Congo notified the Board that the state-mandated PC transition is complete.
