**Board Chair's Opening Remarks, Reading of the Board's Mission & Call to Order at 10:01 a.m. by Caitlin Thompson, LMT.**

The regularly scheduled Open Session meeting of the Maryland State Board of Massage Therapy Examiners was held virtually on March 23, 2022. The meeting was called to order at 10:01 a.m. by Board Chair Caitlin M. Thompson, LMT. Roll call was taken and all Board Members were present.

**Review/Approval of the Open Session Agenda** – Paula Jilanis motioned to accept the Open Session Agenda; 2<sup>nd</sup> by Margaret Hayes. The motion passed. Board Vote: 7/0/0.

**Review/Approval of the Open Session Minutes for February 23, 2022** – Margaret Hayes motioned to accept the Open Session Minutes; 2<sup>nd</sup> by Paula Jilanis. The motion passed. Board Vote: 7/0/0.

#### **OLD BUSINESS - MATTERS FOR REPORTING**

**BOARD CHAIR REPORTS** – (*Caitlin Thompson*) - No report.

**EXECUTIVE DIRECTOR'S REPORT** – (*Sharon J. Oliver*)

**Security Incident – Network Reconnection Update** – The Board continues to operate using Mi-Fi & cellular phone hot spots. Executive Directors are being asked to sign a network reconnection agreement; however, several nuances must be addressed. The Executive Directors will continue to monitor the situation.



**HB220/SB37 – Massage Bill – Hearings Update** – The two Massage Bills have crossed over into the respective chambers. An amendment on SB37 reduced the civil penalty from \$50,000 to \$10,000. A House subcommittee hearing on SB37 is scheduled for March 24, 2022.

**HB1455/SB899 – Health Occupations Boards- Infrastructure Bill Update** – There was an unfavorable vote in the Senate on SB899. HB1455 remains in the House Rule Committee. The crossover date was Monday, March 21, 2022; therefore, HB1455 will not pass.

**Financial Disclosure Filing Due April 30, 2022** – Board Members were reminded to complete their financial disclosure statements by April 30, 2022.

**Final Copy of Revised Bylaws** – Informational only – Included in the board packets is the final copy of the revised bylaws.

**Massage Online JP Examination Update** – Beta testing was completed successfully in February 2022. Invitations were sent to applicants to take the online JP examination starting in March 2022. - **HB533 – Occupations and Professions-Licensees, Certificates, and Registration-Immigrants** – No position.
- **HB903 – Maryland Non-Discrimination in Health Care Coverage Act** – No position.
- **HB1016/SB711– Health Occupations-Athletic Trainers Dry Needling Registration** – No position. The Board will continue to monitor.
- **HB1364 – Health Care Freedom of Conscience** – No position.
- **SB780 – Cybersecurity Governance Act of 2022** – Support with Amendments. The Board will continue to monitor.



- **SB812– State Government – Cybersecurity – Coordination and Governance** – Support with Amendments.
- **HB1346 State Government – Cybersecurity – Coordination and Governance** – Passed in the House; waiting for hearing in the Senate (*Lillian Reese received the bill shortly before the start of the Board meeting*).

Sharon Oliver advised the Board that several bills have come to the attention of the Board shortly before the meeting. They impact the network, infrastructure, and IT Staff. The Board will be apprised of their developments. Ms. Oliver thanked Lillian Reese and Tony DeFranco, Board Counsel, for their work and guidance during this Legislative Session.

**2022 Renewal Requirement: Implicit Bias Training** – In 2021 the legislators passed a law requiring all health care providers to complete a one-time only “Implicit Bias Training” course at their first renewal after April 1, 2022. 1 CEU hour will be awarded for completion of the training. An eblast was sent to LMTs and RMPs with the link to approved courses on the Cultural and Linguistic Health Care Professional Competency Program’s website. Board Discussion.

  - 3 Hours Ethics or Jurisprudence
  - 3 Hours in Communicable Diseases including HIV/AIDS

- Current CPR Certification
