Roll call was taken and all Board Members were present with the exception of Caitlin Thompson, LMT, Board Chair.

Review/Approval of the Amended Open Session Agenda – Paula Jilanis motioned to accept the Amended Open Session Agenda; 2nd by Stephen Conti. The motion passed. Board Vote: 6/0/0.

OLD BUSINESS - MATTERS FOR REPORTING

BOARD CHAIR REPORTS – (*Kirsten Bodnarchuk*) – No report.

EXECUTIVE DIRECTOR'S REPORT – (*Sharon J. Oliver*)

SB37 Massage Therapy Bill Passed in Both Chambers – The Massage Therapy Bill passed in the House and in the Senate.

Security Incident – The Board is still operating on a Mi-Fi connection. The MDH reconnection agreement still poses many concerns. Board ED's are collaborating to identify a workable resolution.



Boards and Commission 2015-2019 Legislative Audit Report – The report contains several repeat audit deficits affecting several Boards. The Massage Board remains in good standing.

Financial Disclosure Filing due April 30, 2022 – Final Reminder. Board Members were reminded to complete their financial disclosures.

END OF LEGISLATIVE UPDATE – (Lillian Reese) – The 2022 Legislative Session ended April 11, 2022. In preparation for the 2023 Legislative Session, concept papers will be due June 1, 2022.

Legislative Bills Of Interest Update

SB77 – Investigation Right to Counsel – Board position: Letter of Concern. The bill did not pass.

SB11 – Preapplication Determinations for Criminal Convictions – Board position: Letter of Concern. The bill did not pass.

SB899/HB1455 – Secretary’s Infrastructure Bill – Board position: Opposed. Bill did not pass.

SB37 – Massage Bill – Passed, effective date- October 2022.

HB625/SB 440 – Commission to study the Healthcare Workforce Crisis in Maryland – Passed, effective date – July 1, 2022.

Thank you to Lillian Reese and Tony DeFranco, Senator Augustine, Delegate Kelly, Amelia Mitchell of AMTA, Board Members, and Staff for their work during this legislative session.

Staffing Update – An individual has been identified for the Chiropractic License Coordinator



position. The selected person is scheduled to start on May 18, 2022. Serita Anderson has returned to assist with Board operations on a contractual basis. The Massage Licensing Coordinator position has been posted. Thank you to Kirsten Bodnarchuk for her assistance in the interview process.

Per Diem Policy – The per diem policy needs to be reviewed. An ad hoc committee will be formed to review the per diem policy.

Funding Balance – Due to the cybersecurity attacks, the Board has been unable to receive complete budget, expenditure and revenue reports since November 2021. As of April 19, 2022, the Massage Board's financial position is as follows: Revenue collected \$135,954; Expenditures: \$370,929.66; 2021 Carryover balance: \$687,583.11; Total Fund Balance: \$452,587.45.

Anne Arundel Community College Program Change – Anne Arundel Community College has submitted a letter advising of changes in their certificate program. Contact hours have decreased from 645 to 615 hours.

Fortis Institute Tuition Changes – MHEC Notification – FYI - The Board has received notice of tuition changes in Fortis's massage program, effective December 2021.

COMMITTEE REPORTS

Advisory Committee – (*Kirsten Bodnarchuk, LMT*)

2023 Concept Papers – The committee is working on two concept papers. The first paper will add a section for reinstatement options for disciplined licensees/registrants; and remove the option of a stay while a final of the Board is under judicial appeal; close a loophole in the definition of massage therapy; and classify the unlicensed practice of massage as a felony. Tony DeFranco clarified the definition of 'stay.' The Board voted to accept the recommendations submitted by the Advisory Committee. Board Vote: 6/0/0.

The second concept paper adds acupuncture to the definition of massage, remove the word treatment from §6-101(f)(3)(i) and repeal Section §6-403. The Board voted to accept the recommendations submitted by the Advisory Committee. Board Vote: 6/0/0.
