Dr. Stephanie Chaney called the meeting to order at 10:00 A.M.

Review of Agenda and Minutes

The September 13th Agenda was approved as drafted. Dr. Fedorczyk made a motion to accept the Agenda; Dr. Frieman seconded, and the motion was unanimously voted.

The August 9th Minutes were approved as drafted. Dr. Fedorczyk made a motion to accept the Minutes; Dr. Frieman seconded, and the motion was unanimously voted.

Review of Administrative Staff Issues, Mr. J.J. Vallone, Executive Director

- Final Update on Closeout of FY2012 Budget: The Board has a carryover of \$350,000; we will not need to raise fees unless there is an unforeseen circumstance. The Budget is set at \$1,000,000+ because of an increase in direct/indirect costs. Unfortunately, there are no pay raises for staff; however, in January 2013, there will be a 2% pay increase across the board for State employees.
- There is a Regulations Subcommittee Meeting scheduled for September 20, 2012, 10:00 A.M. 2:00 P.M., Room 100; it is open to the public. The meeting is listed in two editions of <u>The Maryland Register</u> (August 24th and September 7th) and also on the Board's website; the topic to be discussed is the massage therapy recordkeeping regulations. <u>NOTE</u>: The Subcommittee Members met briefly this morning before the Board Meeting began. Present at the meeting were: Ms. Biagiotti, LMT (Chair), Mr. Gerber (Board Counsel), Dr. Nou (D.C.), Ms. Harrison, LMT, and Mr. Cox, LMT.

- There is a Disciplinary Hearing @ 1:30 P.M. today; refer to the Executive Session for details.
- ▶ Update Regarding 2012-2014 Massage Therapy Biennial Renewal Ms. Congo: Out of 4,800 licensed massage therapists and registered massage practitioners, 368 have renewed and have received their licenses/registrations. Also, 380 licensees/registrants have been audited for CEUs; 40 are tax delinquent; and 250 have bad addresses (of which 17 have paid the \$100 penalty). There have been problems with a small percentage of users of Apple products; the IT Department says these individuals may need to update their browsers.
- ➤ Update on the Board of Physical Therapy's Proposed Dry Needling Regulations: The regulations are currently being reviewed by the DHMH Health Secretary, Dr. Joshua Sharfstein. The Board will have the opportunity to formally review, discuss, and comment on the regulations once they have been published.
- ➤ Update on the North Carolina Dentistry Board vs. the Federal Trade Commission (FTC): The DHMH Boards and Commission are taking notice of the outcome of this important case (involving teeth whitening) which has been in litigation for the past couple of years, costing the Board over a million dollars. The FTC stated the NC Dentistry Board is in violation of the antitrust laws. The NC Circuit Court should probably give its opinion sometime in 2013.

Petition from Ms. Anne Marie Johnson, Massage Therapy Applicant

Ms. Johnson petitions the Board to waive the accreditation requirements and accept her non-accredited massage school training from the Southeastern School of Neuromuscular and Massage Therapy in Charleston, SC. When Ms. Johnson graduated in June 2000, Southeastern had a state license; in February 2001, they received accreditation from The Accrediting Commission of Career Schools and Colleges of Technology. Ms. Johnson, who has a Bachelors Degree and passed the NCETMB exam, is currently licensed in the state of DE. Ms. Biagiotti made a motion to waive the accreditation requirement and accept Ms. Johnson's massage application for Maryland licensure as sufficiently meeting equivalency standards. Ms. Harrison seconded, and the motion was unanimously voted.

Petition from Ms. Jessica A. Boring, RMP

Ms. Boring petitions the Board to waive the regulatory administrative penalty of \$100.00 imposed for failure to notify the Board of address change. Ms. Boring's husband is in the military and since they frequently move around, she has two addresses: a) military duty stations (temporary); and b) Maryland address (permanent legal residence) which is currently on file with the Board and has not changed. Mr. Cox made a motion to waive the regulatory administrative penalty of \$100.00. Ms. Harrison seconded, and the motion was unanimously voted.

Hirsh, D.C., Maryland Chiropractic Association (MCA), complimented the Board on its fair-minded approach to handling various issues under current and past leadership (especially under Dr. Kay O'Hara and Dr. Duane Sadula, both former Board Presidents). Many chiropractors have expressed to MCA the professionalism and positive high-level quality of the Board. MCA intends to have an on-going presence at future Board meetings. Dr. Hirsh also spoke about the issue of chiropractic practices owned by non-health care entities. The Board does not have jurisdiction of non-health care owners because they are not chiropractors. Dr. Chaney will look into Massachusetts' handling of this issue.
- 2. Ms. Cher Hunter, Director, Massage Therapy Program, Community College of Baltimore County, requests that the Board looks at repealing the regulatory requirement that massage school instructors be NCBTMB certified in order to teach.
