Panel Enrollment Update

- These uploads are how we can track hospitalization utilization
- So far, we have received panel uploads from 7 of the 9 grantees



Pathways Reporting Data Totals

Grantees and evaluators are encouraged to use both quantitative and qualitative information to tell the story of their programs. The hospitalization data through CRISP is one part of that story.

- Below are aggregated totals from five grantee organizations with enough data in the 6-month pre/post timeframe
- The data available in the table is through 6/30/2023 and it includes:
 - Participants enrolled by 12/30/2023
 - And organizations with at least 11 visits to prevent cell suppression
- In conclusion, while all organizations are different, there are positive trends in the data




Next Pathways Data Run
