FY 2022 Legislation Affecting CHRC

- **SB 607/HB 906 – Health Equity Resource Communities – Modifications**
 - Delays the release of the HERC RFP by one year (October 2023)
 - HERC fund can be used for staff and CRISP
 - Takes effect July 1, 2022
- **SB 802– MD Consortium on Coordinated Community Supports – Membership, Coordinated Community Supports Partnership Fund - Revisions**
 - Adds two additional staff to the CHRC for a total of four
 - Adds additional members to the Consortium
 - Staggers Appointment terms
 - Chair designated by the Presiding Officers

CHRC FY 2023 Budget

- FY2023 Budget bill (SB 290) Passed Enrolled
- CHRC Budget slated for a total of **\$73 million**:
 - **\$8 million** for traditional grants;
 - **\$15 million** for Health Equity Resource Communities (does not include the \$14 million of Pathways grants just awarded); and
 - **\$50 million** for Maryland Consortium on Coordinated Community Supports
 - 7 new FTEs (HERC – 3 and Consortium- 4)
