



Daily Cases by Specimen Date**



Daily Testing Volume





Maryland Disparities in COVID Cases and Deaths




Blacks are overrepresented in cases and deaths (more co-morbids)

Hispanics are overrepresented in cases, not deaths (young population, job exposures?)


Whites have deaths out of proportion to cases (older pop)




COVID-19 Growth in Maryland

Current Recommendations

- Both CDC and AAP recommend continuation of essential services, including immunizations, during the COVID-19 pandemic
- Prioritize well child and immunizations for <24 months of age.

Current Recommendations (Cont)

- All well-child care should occur in person whenever possible and within the child's medical home where continuity of care may be established and maintained
- Identify children who have missed well-child visits and/or recommended vaccinations and contact them to schedule in person appointments
- Inform families about the strategies already implemented in primary care medical home offices to assure safety.


MMWR Article – May 8, 2020

- "Effects of the COVID-19 Pandemic on Routine Vaccine Ordering and Administration – United States, 2020"
- Sharp decreases in ordering and administrations noticed starting in mid-March (national emergency declaration) and continuing though April
- Smaller decline in administrations to <24 months in line with CDC and AAP recommendations



[†] VSD data depict weekly measles-containing vaccine doses administered by age group (age ≤24 mos and >24 mos−18 yrs).




Maryland Vaccinations

- Source: ImmuNet (Maryland's Immunization Information System (IIS))
- Compared Jan-April 2019 to Jan-April 2020
- Looked at the number of vaccinations by age (0-18 yo) and vaccine type
- Not much difference Jan-Feb 2019 vs Jan-Feb 2020
- Began to see change in March and then more significant change in April



Vaccinations by Age – March


Comparison of doses administered by age, March 2019 vs March 2020, Maryland


Vaccinations by Age - April

Comparison of doses administered by vaccine type, March 2019 vs March 2020, Maryland



Possible Barriers to Vaccination

- Parents abiding by stay at home orders
- Parents not wanting to expose newborns/infants to potential sick patients in provider's office
- Restrictions on public transportation
- Parents not viewing immunization as an essential service (e.g. child is not sick/need medical attention)
- Providers office closed or limited hours



Strategies to Improve Vaccinations

- Communication to parents about the importance of routine vaccines and safe well-child visits
- Communication to parents about safe clinic practices you have implemented in your office
 - Sick and well visits scheduled at different times
 - Separating patients spatially
- Guidance to providers about reminder recall (EHR or ImmuNet), prioritization of catch-up
- Promote Vaccines For Children and Medicaid eligibility for Americans who are now uninsured

Physician Support Line – (888) 409-0141

CDC Guidelines for COVID Patient Management

- Healthy people can be monitored, self-isolated at home
- People at higher risk should contact healthcare providers early, even if illness is mild
- Older adults and people with severe underlying chronic medical conditions are at higher risk, need closer contact
- Emergency Department and Hospitals only when needed not for screening or low risk/minimal disease
- Guidelines are important and powerful tools, but remember providers' clinical experience and judgment are key to care



Billing for End-of-Life Planning

- Billable event with AWV or Separate Encounter
- ❖ 99497 Advance care planning including the explanation and discussion of advance directives such as standard forms (with completion of such forms, when performed), by the physician or other qualified healthcare professional; first 30 minutes, face-to-face with the patient, family member(s), and/or surrogate
- 99498 Advance care planning including the explanation and discussion of advance directives such as standard forms (with completion of such forms, when performed), by the physician or other qualified healthcare professional; each additional 30 minutes (List separately in addition to code for primary procedure)

Caregiver Services Corps (CSC)



- **❖** OPEN for primary care providers STATEWIDE!
- ❖ The CSC call center (800-337-8958), staffed with specialists 7 days a week, matches volunteers for urgent and temporary assistance to people over 65 years old in their homes to help with:
 - > Self-administration of medications
 - ➤ Ambulation and transferring
 - ➤ Bathing and completing personal hygiene routines
 - ➤ Meal preparation and arranging for delivery of groceries and/or prepared meals
 - Teaching how to use video technologies to connect with loved ones and/or healthcare providers
- Healthcare providers should alert their patients they are being referred
- ❖ Seniors, their families and friends may call 211 to seek help and referrals to the elderly in need

MedChi/CareFirst/Backline Grant

CareFirst BlueCross BlueShield (CareFirst) and the Maryland State Medical Society (MedChi) launched a grant program that will equip additional Maryland physicians with the technology they need to provide needed virtual care during the COVID-19 pandemic and beyond

Eligibility Requirements

- The medical practice and medical license are in Maryland
- The medical practice is a private, independent group of five or fewer physicians
- The practice enrolls in Backline after March 1, 2020 as the result of the COVID-19 crisis
- MedChi has confirmed the practice's enrollment with DrFirst
- Enrollment in Backline occurs before December 31, 2020

Federal Emergency Funds for Small Business

- ❖ <u>Disaster Loan Assistance</u> (from Small Business Administration)
 - ➤ Low-interest financial disaster loans for working capital in small businesses suffering substantial economic injury due to COVID-19
 - > FAQs
- CARES Act (pending federal legislation)
 - > Sets up a \$350 billion loan program for small businesses
 - ➤ Small businesses can apply for low-interest loans that cover up to 2.5 months of expenses
 - ➤ Maximum loan amount is \$10 million
 - > Loans can cover payroll, rent, utilities, or existing debt obligations
 - ➤ Interest rates cannot exceed 4%
 - ➤ If employer continues to pay workers through June, the amount of the loans that went toward eligible costs would be forgiven
 - Loans will be available through the <u>Small Business Administration</u> and Treasury-approved banks, credit unions, and some nonbank lenders



State Emergency Funds for Small Business

- COVID-19 Layoff Aversion Fund (from Maryland Governor Larry Hogan and Maryland Dept. of Labor)
 - ➤ Designed to support businesses undergoing economic stresses due to the pandemic by minimizing the duration of unemployment resulting from layoffs
 - Award of up to \$50,000 per applicant
 - ➤ Will be quick deployable benefit and customizable to specific business needs

State Emergency Funds for Small Business

- ❖ Maryland Small Business COVID-19 Emergency Relief Loan Fund
 - > \$75 million loan fund (to be paid to for-profit business only)
 - > Loans are up to \$50,000
 - > No interest or principal payments due for the first 12 months
 - Thereafter converts to 36-month term loan of principal and interest payments, with interest rate of 2% per annum
- ❖ Maryland Small Business COVID-19 Emergency Relief Grant Fund
 - > \$50 million grant program for businesses and non-profits
 - > Grant amounts of up to \$10,000
 - ➤ Grant amounts not to exceed three months of demonstrated cash operating expenses for Q1 2020
