This fee schedule outlines Maryland Medicaid enhanced rates for eligible primary care providers, effective August 1, 2025. The enhanced rates will be for

FFS Somatic Eligible Providers:

- (1) Physician assistants (PT 80);**
- (2) Nurse practitioners (PT 23); and**
- (3) Physicians (Provider Type 20), with the following**

FFS providers must have their appropriate American Board of Medical Specialties (ABMS) board certifications uploaded in ePREP in order to be approved for the rate increase. In addition, eligible FFS providers must self-attest their PCP status in ePREP by submitting a supplemental application.
