Health Data Overview

David Mann, M.D., PH.D., Epidemiologist

Pronouns: he, him, his

Presenter

Dr. David A Mann is the Epidemiologist at the Office of Minority Health and Health Disparities (MHHD) in the Maryland Department of Health, at 75% FTE. His other 25% FTE is spent as an Instructor in the Department of Epidemiology and Public Health at the University of Medicine School of Medicine. Dr. Mann received his BA in Biology from The Johns Hopkins University in 1978, his MD from Harvard Medical School in 1982, and his PhD in Epidemiology from the University of Maryland, Baltimore in 2007. Before coming to Maryland for epidemiology and public health training in 1998, Dr. Mann practiced primary care medicine in the greater Boston area for 14 years. At DHMH Dr. Mann was a co-author of the Maryland Plan to Eliminate Minority Health Disparities, released in 2006 by MHHD; and principal author of the Maryland Chartbook of Minority Health and Minority Health Disparities Data, released in 2007, 2009 (2nd Edition) and 2012 (3rd edition) by MHHD. He has been an invited speaker on health disparities data at several venues. At DEPH in UMB SOM, Dr. Mann is the faculty co-leader of the Departmental Journal Club, participates in the Department's epidemiology teaching for medical students, and teaches the summer course in Chronic Disease Epidemiology for graduate students.

Mark Martin, PH.D., MBA, Director

Dr. Mark Martin currently serves as the Director for the Office of Minority Health and Health Disparities for the State of Maryland. He has a passion for improving patient-centered care and for strengthening the continuum of care in communities through public and private

partnerships. Dr. Martin brings over 25 years of combined professional experience in public health, hospital operations, financial services, and community and faith-based organizations.

In addition to earning a PhD in Leadership and Change from Antioch University where his seminal research focused on the role of servant leadership characteristics in developing an environment of empathic care in a primary care setting, Dr. Martin has earned an MBA and MHA from Pfeiffer University and an MA in Leadership from Antioch University. His combined academic and professional experience continues to fuel Dr. Martin's efforts to research and develop innovations to improve patient-centered care and the patient experience.

Elizabeth Chung, MS Pronouns: she, her, hers

Mrs. Elizabeth Chung is a native of Hong Kong, China and immigrated to the United States since 1970. She has been a strong advocate for minority health for the past 45 years. Mrs. Chung completed her graduate study in public health from the Pennsylvania State University in 1981 and has dedicated her professional work to issues surrounding health equity since then. She has been a founding member of four community-based agencies since the early 1990's. Currently, she is the founder and Executive Director of the Asian American Center of Frederick (AACF), whose mission is to support immigrants with essential skills to be independent and successful contributors to the community. Under her leadership, AACF is a leading entity in addressing health disparities through partnership with collective impact. Her primary focus has been health equity through cultural competency and language access for the Limited English Proficiency population. Mrs. Chung has served on a variety of advisory committees, boards, and commissions in various capacities with the Health Services Cost Review Commission, Maryland Health Benefit Exchange and multiple others. Through her volunteerism and active public service, Mrs. Chung has received numerous awards, including the Jefferson Award – Ohio; Friends of Foreign Language – Maryland Association of Foreign Languages; and many more within Frederick County, Maryland and Washington D.C. In 2020, Mrs. Chung was a national recipient of the New York Life Foundation – Love Takes Action Award. Most recently, Mrs. Chung developed the Community Health Worker Program in western Maryland, expanding the public / community health workforce development to address health disparities for the most vulnerable populations in the community. Ms. Chung has devoted half to her career to volunteerism promoting social justice and improvement of the lives of immigrants.

Kerry Hawk Lessard, MAA, Medical Anthropologist

Kerry Hawk-Lessard, a descendant of the Shawnee tribe, is an applied medical anthropologist working in Urban American Indian Health. While an undergraduate at Florida Atlantic University, Kerry completed fieldwork with HIV+ Haitian immigrants living in South Florida. It

was in the course of this work that she became aware of the importance of culture, both in the ways it shapes our understanding of health and wellness, but also how deeply held beliefs impact decision making and behavior. Ms. Lessard currently serves as the executive director of Native American Lifelines, a Baltimore-based Urban Indian Health Program that serves Urban Indian Americans and Alaska Natives in the Mid-Atlantic and Northeast regions of the United States. The organization focuses on the "health and well-being of native people" who often have to deal with "the way we've been disenfranchised from Indian culture." Kerry and her team work to educate, support, empower, and protect Native Youth. Applying decolonization theory and engaging culturally informed practices such as talking circles, traditional arts, and indigenous foodways, Native American Lifelines seeks always to honor and strengthen cultural identity, thereby building resiliency and creating opportunities for better health outcomes. Kerry's vision remains guided by words attributed to Tecumseh, a great leader from her tribe: "A single twig breaks, but the bundle of twigs is strong." Above all else, it is Lifelines' desire to grow a strong bundle.

Lucia Zegarra, B.S., Biology

Ms. Zegarra, born in Peru, earned an International Baccalaureate degree from the German Peruvian School, Alexander Von Humboldt and advanced her education in the United States earning a baccalaureate degree in Biology at the University of Maryland, Baltimore County. Ms. Zegarra has held a broad range of positions wherein she focused on improving community health through educating, mentoring, and counseling. Her roles include but are not limited to Community Health Programs Director, Health Coach, and Rehabilitation Counselor. She is also certified by the Maryland Department of Health as a community health worker and a certified Health Minister from Wesley Theological Seminary in Washington D.C. Ms. Zegarra's multilingual abilities have allowed her to use her language skills to assist limited English proficiency populations. Her understanding of the complexities of behavior helped her to successfully manage Montgomery County's first Food is Medicine program for food insecure patients with type 2 diabetes. Her passion to serve communities, especially those most at risk for social injustice and health inequality, led her to managing covid-19 vaccination clinics in underserved areas in Montgomery and Prince George's County. Currently, she serves as the Community Impact Director in the Greater Washington Region for the American Heart Association. Her role focuses on improving health outcomes in diverse communities by developing and implementing strategies to prevent or manage cardiovascular disease, hypertension and stroke.

Ms. Zegarra finds time to serve on several boards and councils such as Community FarmShare board of directors, the Montgomery County Food Council Alumni Circle, and the Latin American Advisory Group to the Montgomery County Executive among others. She has offered many

presentations and publications addressing the needs of vulnerable populations such as food insecurity, social and mental health dilemmas among teens, and promotion of upward mobility strategies among Latin populations. Ms. Zegarra has shared her expertise in many trainings including but not limited to topics addressing community health worker training, diabetes, and mental health.

Mallory Finn Legg is the director of Project Heal (Health, Education, Advocacy and Law) community-based program of the Maryland Center for Developmental Disabilities (MCDD) at Kennedy Krieger Institute. Project HEAL is Maryland's only comprehensive medical-legal

partnership, which provides advocacy and civil legal services for low- and moderate-income children with disabilities who receive clinical services at Kennedy Krieger. Ms. Legg earned a bachelor's degree in sociology from the University of Delaware and a Juris Doctor at the University of Maryland Francis King Carey School of Law. She interned at Project HEAL during her second and third years of law school and started as a staff attorney in August 2014. Mallory is on the development committee and is a co-chair of the membership committee for the Council of Parent Attorneys and Advocates. In April 2015, Mallory received an award for dedication to her law school's public interest organization, the Maryland Public Interest Law Project. Mallory received *The Daily Record*'s Leading Women Award in December 2017 and the Association of University Centers on Disabilities (AUCD) Young Professional Award in November 2017. Mallory served on the board of directors of the Collaborative Project of Maryland from 2016-2019.

Maureen van Stone is the director of the Maryland Center for Developmental Disabilities (MCDD) at Kennedy Krieger Institute and the founder of Project HEAL (Health, Education, Advocacy, and Law), a MCDD community-based program. Presenter – 988 Suicide & Crisis Lifeline

Mr. Edward Soffe is a Program Coordinator within the office of Early Intervention and Wellness Services for the Behavioral Health Administration. He is responsible for Screening, Brief Intervention, & Referral to Treatment (SBIRT) initiatives and is also the agency lead for both the state crisis services hotline (211 Press 1), and most recently, efforts related to 988. Ed works

closely with statewide behavioral health leaders and stakeholders in the development of both our statewide crisis hotline system and now our support of 988 initiatives. Currently, he supervises a team of two full-time employees and manages multiple federal and state program budgets.

Prior to his work with the Behavioral Health Administration, he was the Director of the Catoctin Summit Adolescent Program (Washington County Maryland Health Department). His background also includes serving as a Regional Social Work Supervisor (Maryland Department of Juvenile Services), as a Social Work Supervisor (Washington County Maryland Department of Social Services), and as the Director of the Shoemaker Center men's program (Carroll County Maryland Health Department).
