Maryland Medicaid at a Glance

- Maryland Medicaid (Medical Assistance/MA) offers free or low-cost health coverage to eligible low-income individuals across various demographics, covering a broad spectrum of services.
- Approximately one in four Maryland residents (25%) are covered by Medicaid.
- HealthChoice is the name of Maryland's managed care program.
- Between 2021 and 2022, Approximately 3,291 transgender patients on Maryland Medicaid (160 on fee-for-service and 3,131 on managed care) received gender-affirming care.*

Maryland Medicaid - Managed Care Organizations (MCOs)

- Managed Care Organizations (MCOs) are the health plans that participants enroll in to receive their healthcare services. Medicaid recipients are required to enroll in a specific MCO to access their benefits.
- There are 9 MCOs participating in the HealthChoice Medicaid Programs:



Benefit Background

- Gender affirming care services were expanded in January 2023 as a result of HB0283, Gender-Affirming Treatment (Trans Health Equity Act). Electrology is a vital component of gender affirming care.
- The program expanded to include medically necessary gender-affirming care, such as hormone therapy and specific surgeries, aiming to ensure safety and respect for transgender and gender-expansive individuals.
- Effective July 1, 2024, all providers enrolling as Electrologists, should enroll using the provider type (PT) GA - Gender Affirming Care.

Orientation to Terminology

- ePREP: Electronic Provider Revalidation and Enrollment Portal
- Provider Type: This is the category of a healthcare provider.
 - Gender Affirming Treatment - Electrologists and Medical Tattoo Artist
- Atypical Provider: MDH creates an National Provider Identifier (NPI) placeholder number for certain provider types by adding a leading "5" to the beginning of their Medicaid provider number (MA) number.

Coding and Billing

- Eligible Providers must submit claims using CPT code 17380 (Electrolysis Epilation for every 30 minutes).
- The Maryland Medicaid reimbursement rate for this CPT code is \$90.
 - For example, if you are administering electrolysis to members in 1 hour increments, you should bill for 2 units of the CPT code.
- Claims Processing timeline: 30 - 60 days

Electrology Provider Enrollment

- To enroll as an atypical provider, no NPI is needed; therefore Electrology providers should not submit an NPI when enrolling.

 - Ensure your license number is entered correctly
 - Complete the form in one session. If you need to complete it in more than one sitting, remember to save your progress
 - Check the ePREP portal frequently.

Tips for Successful Contracting with MCOs

Working with MCO(s)

- Once you enroll, reach out to an MCO, and make the necessary arrangements for reimbursement purposes.
- If and when you experience delays in reimbursement, please contact the MCO. Some MCOs may assign provider representatives to assist with delays in reimbursement and other billing assistance.
- In some cases, you may enter a temporary contract or single case agreement (SCA) with an MCO. This will allow a patient to receive care from an out-of-network provider.

Preauthorization Process

- MCOs will work with Electrology providers when you decide to enroll in Medicaid.
- Some MCOs may have a pre-authorization (PA) request form that providers should complete and submit. This should include documentation that the hair removal procedure is part of Gender-Affirming care and is medically necessary.
- When submitting a PA form, providers will need the atypical provider number, the member's MA #, the member's diagnosis, and the CPT code for the service.
