Re: 2020 Joint Chairmen's Report (p. 117) – Report on Reimbursement Methodology for Enteral Nutrition

Dear Chairs Guzzone and McIntosh:

In accordance with the 2020 Joint Chairmen's Report (page 117), the Maryland Department of Health (MDH) presents this update regarding the development of a reimbursement methodology to cover the costs associated with enteral nutrition services.

MDH met with stakeholders regarding prospective changes to the reimbursement methodology for enteral nutrition services during the summer of 2020. Based on these discussions and stakeholder feedback, MDH updated its reimbursement methodology to cover these services and is in the process of promulgating regulations at COMAR 10.09.03.04-.06 and 10.09.12.04 and .07. The effective date of the regulations will be June, 14, 2021. The regulatory changes will update reimbursement for these codes and shift coverage of enteral nutritional products from the Medicaid Pharmacy Program to the Durable Medical Supplies/Durable Medical Equipment (DMS/DME) Program, pursuant to 42 CFR § 440.70 - Home Health Services. The new reimbursement methodology sets rates for codes at 150% of the Medicare rate as of CY2020, Q2. Codes not covered by Medicare are priced using an average of eight states' rates. Relevant codes and reimbursement rates are included below.
