Introduction

Recent efforts to expand home and community-based services (HCBS) have led to significant increases in Community First Choice (CFC) program expenditures, including spending under the Community Options Waiver. The committees request that the Maryland Department of Health (MDH) submit two reports on CFC program spending. The reports will include monthly enrollment, utilization, and cost data that aligns with actual budget expenditures under the CFC program, and this initial report includes data that reconciles to actual spending in fiscal 2022 and 2023. Each report also provides:

- the number of Community Options waiver slots filled in fiscal 2023 and fiscal 2024 year to date;
- the number of Community Options waiver applications sent to individuals on the registry each month and the results of that outreach (including the number of applications returned and processed);
- updates on changes to registry operations to improve efficiency in taking individuals off of the registry and efforts to determine financial and medical eligibility for individuals while they remain on the registry;
- the number of individuals on the Community Options waiver registry; and
- an update on any activities or efforts to implement the plan to reduce the Community Options waiver registry by 50% submitted to the General Assembly in February 2023.

Monthly Enrollment Data and Expenditure Data FY 2022 and FY 2023

The federal Public Health Emergency (PHE), as a result of the COVID-19 pandemic, and the subsequent maintenance of effort (MOE) between states and the Centers for Medicaid and Medicare Services (CMS) impacted the expenditure, enrollment, and utilization data for FY 2022 (July 1, 2021 – June 30, 2022) and FY 2023 (July 1, 2023 - June 30, 2023) because participants could not be disenrolled from Medicaid and its programs, regardless of the participant no longer meeting program eligibility requirements. The MOE provision was in effect from March 18, 2020 and through March 31, 2023.

Effective April 1, 2023, the MOE was decoupled from the PHE through the Consolidated Appropriations Act of 2023¹ signed into law by Congress on December 29, 2022. As a result, the Maryland Department of Health (MDH) began its conservative unwinding efforts to disenroll Medicaid participants from its programs who were no longer eligible. MDH's unwinding strategy will take one (1) full year to complete as participants are reassessed for financial, medical, and technical eligibility criteria upon their annual Medicaid redetermination. As such, expenditure, enrollment, and utilization data may include individuals who would have otherwise been ineligible for Medicaid benefits absent the MOE.

The enrollment, utilization, and expenditure data are derived from the Hilltop Institute's² monthly waiver and program enrollment trends report which is submitted to MDH on a quarterly basis. Medicaid providers have one (1) year from the date the service is provided to submit claims for services rendered. As such, MDH will need additional time to analyze actual expenditures in consideration of the time allocated for claims submission and payment.

In Table 2 above, waiver expenditures reflect those services that are included in the Community Options Waiver specifically, while non-waiver services are State Plan services that participants are entitled to receive as part of their Medicaid coverage, and include items such as pharmacy and durable medical equipment and disposable medical supplies. Additionally, Community Options waiver participants can access CFC services; thus, CFC expenditure data is inclusive of CFC participants and Community Options waiver participants receiving CFC services.

Community Options Waiver Slots FY 2022 and FY 2023

The Community Options waiver program was approved for 6,348 slots for FY 2022 and FY 2023. The waiver application was renewed by CMS for a five-year period beginning January 1,

2023. The approved waiver slots remain at 6,348 until Waiver Year 5, beginning January 1, 2027, which is approved for 7,500 slots. In FY 2022, 4,679 of the 6,348 waiver slots were filled and in FY 2023, 4,548 of the 6,348 waiver slots were filled.

Community Options Waiver Applications

Throughout Calendar Year (CY) 2022, 300 invitations were sent each month to registrants on the Community Options Waiver Registry. Pursuant to SB 28 and SB 636 passed during the 2022 legislative session, MDH is steadily increasing the invitations mailed each month to registrants. In March 2023, MDH began inviting 400 individuals from the registry to apply for the program and in June 2023, the monthly invitations increased to 500 individuals invited to apply from the registry. Enhancements to the Maryland Medicaid's data management system, LTSS*Maryland*, were required prior to increasing the monthly invitations; those system enhancements were released in April 2023. Additionally, MDH, specifically the Office of Long Term Services and Supports (OLTSS), is actively recruiting for a number of positions to assist with processing the increased volume of invitations and subsequent applications.

A Medicaid application typically has a six-month life cycle. However, a temporary extension of the six-month life cycle was granted during the PHE and continues to be applied, as appropriate, due to administrative delays on part of offices within MDH's Medicaid Administration, OLTSS and the Eligibility Determination Division (EDD). As such, applications remain pending a decision beyond the six-month consideration period to ensure that registrants who qualify for participation are able to access the program as soon as possible. Table 4 below, indicates at least 300 invitations were sent each month in CY 2022. Table 5 is indicative of the metrics for CY 2023 in which 400 invitations were sent beginning March 2023⁶ and 500 invitations were sent beginning June 2023.

Pursuant to SB 28, the time in which an individual has to submit an application upon receipt of an invitation was shortened to six (6) weeks. As such, OLTSS implemented this change in April 2023 with the release of the system enhancement that effectuated the change in time to apply.

Tables 4 and 5 provide additional information such as the number and percentage of applications received, the number of individuals enrolled in the program, and those applications that are pending a decision or have been denied. As applications are received and processed, the metrics reported in tables 4 and 5 may change.

Changes to the Community Options Waiver Registry

There have been no changes to the Community Options Waiver Registry to evaluate a registrant's medical or financial eligibility for the program. As such, the Community Options waiver program continues to have a registry instead of a waitlist. Individuals may contact a Maryland Access Point (MAP) site at any time to place his or her name on the registry. MDH trained MAP sites to complete the Level One Screen for all individuals on the registry to determine an individual's risk of institutionalization. The results place the individual into one (1) of six (6) priority groups, with priority group one (1) being the highest. The MAP can complete a Level One Screen at any time based on an individual's request.

In order to determine this risk, MDH worked with the Hilltop Institute to develop an algorithm utilizing data from the Level One Screen. Eighty percent of the individuals invited to apply to the Community Options Waiver each month are prioritized based on risk of institutionalization and 20 percent of those invited based on length of time on the registry or first come, first served.

Upon receiving an invitation to apply, individuals must submit a Medicaid application to be considered for the program. During the application process, an individual is assessed to determine if the financial, medical, and technical eligibility criteria are met. If all criteria are met, the applicant is enrolled in the Community Options waiver program. If an applicant is denied for one or more of the three eligibility criteria, the applicant may elect to place his or her name back onto the registry by contacting a MAP site and wait to be invited to apply upon receipt of an invitation.

Community Options Waiver Registrants

Table 6 below provides the total number of registrants on the Community Options Waiver Registry for two points in time - July 1, 2022 and July 1, 2023. The total number of registrants is disaggregated into three (3) age groupings - up to age 17, ages 18 through 64, and ages 65 and older. As reflected in the table below, the registry increased by 5,487 individuals between July 2022 and July 2023.

Update to the Plan to Reduce the Community Options Waiver Registry

MDH's plan to address the registry is complex and includes strategies specific to each waiver program. For the Community Options Waiver program specifically, MDH must first recruit human resources to effectively complete the necessary tasks to evaluate and enroll applicants within the regulatory timeframes. Additionally, MDH must work to build provider capacity to support the increase in applicants invited to apply from the registry.

MDH has active recruitment efforts underway to hire staff in merit and contractual roles which are currently assigned to OLTSS. OLTSS hired 2 non-clinical plan of service reviewers in June 2023 and 1 clinical plan of service review in July 2023. After filling those 3 positions, there are 30 vacancies remaining, which are in various stages of the recruitment process, within 3 OLTSS divisions that support the Community Options waiver program. Of those 30 vacant positions, 23 are contractual positions. The remaining 7 vacancies are merit positions. In addition, and equally important, is MDH's efforts to augment staffing resources by way of contractual services. Specifically, MDH is pursuing a diverse team of plan of service reviewers by way of a request for proposals (to be released Fall 2023) and will be using its utilization control agent (UCA) to perform plan of service reviews by Fall 2024.

In addition to staffing resources, provider capacity is critical in ensuring there are enough case managers to serve applicants and participants. OLTSS began partnering with Supports Planning Agencies (SPAs) in April 2023 to build case management provider capacity and prepare for the increased volume of applicants for the Community Options waiver program. SPAs are the case management entities that support applicants and participants with accessing Medicaid and non-Medicaid home and community-based services (HCBS) and supports. SPAs also assist applicants and participants with waiver eligibility determination and maintenance. Since the inception of the Community Options waiver program in 2014, historically, there has been a waitlist for SPA assignments for as many as 300 applicants.

Since April 2023, SPAs have hired additional Supports Planners (SPs) to prepare for increased capacity. In June 2023, OLTSS held its quarterly SPA training and trained 90 new SPs. Within three months, as of July 2023, there is no longer a SPA assignment waitlist, and applicants for the Community Options, CFC, Community Personal Assistance Services (CPAS), and Increased Community Services (ICS) programs are assigned to a SPA immediately. SPAs are consistently assessing their capacity and hiring new SPs to support Medicaid applicants and participants. OLTSS plans to conduct its next regularly scheduled SPA training in September 2023.

Building provider capacity with the SPA network is only the first step in building provider capacity. The Community Options waiver program offers a broad array of supports that help individuals age in place in their communities and with their families. As services and supports are identified to meet the needs of those individuals who qualify for program enrollment, Medicaid-enrolled providers who provide those services and supports will also need to build capacity to support the increase in volume. Given the nationwide shortage in the direct service professionals and nursing workforces, this hurdle will present a greater challenge.

As mentioned previously, OLTSS is actively expanding its glidepath to increase the number of invitations mailed to registrants on the Community Options Waiver Registry. Beginning March 2023, 400 invitations were mailed to registrants and beginning June 2023, 500 invitations were mailed to registrants. As staffing resources increase, OLTSS will continue to build on the number of invitations sent each month until it reaches 700 invitations, as indicated in MDH's plan to reduce the registry. Additionally, in April 2023, OLTSS implemented the legislated, six-week time limit for individuals to submit an application from the point at which they are invited to apply. Registrants are notified of their invitation to apply in writing and assigned a SP who will also contact them directly to confirm receipt of the invitation. A second notice is sent 21 days after the initial invitation to apply, which is another one of MDH's efforts to remind registrants of the program's invitation to apply and the critical timelines associated with the invitation. If an application has not been received 30 days after the final notice, the registrant is deactivated from the registry and the individual must contact the local MAP to be added onto the registry again.
