# Maryland Medicaid Advisory Committee Oral Health Update

 The Department of Health and Mental Hygiene, Office of Oral Health, the Maryland Department of Education and The Children's Oral Health Institute are in conversation about implementation of the 2012 Oral Health Education: Certification & Monitoring Law

### Summary

Requiring the State Department of Education to support and facilitate specified oral health education, develop a process to monitor specified implementation of oral health education, and submit a summary to the Governor and General Assembly on or before December 1, 2015 and every 5 years thereafter; requiring the State Board of Education to encourage specified county boards of education to incorporate specified lessons into the boards' health education curriculum; etc.

II. February is National Children's Dental Health Month

The annual observance of children's dental health began as a one-day event in February 3, 1941 and a one-week event in Akron, Ohio during February 1941. The American Dental Association held the first national observance of Children's Dental Health Day on February 8, 1949. The single day observance became a week-long event in 1955. In 1981, the program was extended to a month-long celebration known today as National Children's Dental Health Month.

Today, NCDHM is a nationwide program and its messages reach millions of people in communities across the country and at numerous armed service bases abroad. Local observances often include poster, coloring, and essay contests, health fairs, free dental screenings, museum exhibits, classroom presentations and dental office tours.
